'Ohu 'Ohu Ko'olau Inc., DBA: Ko'olau Watershed Foundation (KWF) functions as the non-profit arm of the Ko'olau Mountains Watershed Partnership (KMWP) and serves the communities of Oahu by protecting our most valuable resource—fresh water. This is done through conservation actions conducted by KMWP staff across the most important watersheds on the island. The Ko'olau Mountains provide an estimated 364 million gallons of fresh water per day. A University of Hawai'i study calculated that services provided by the forests that cover this range (water recharge, water quality, climate control, biodiversity, and cultural, aesthetic, recreational, and commercial values) have a net present value of \$7.4 - \$14 billion. Half of that amount is attributed to the forest's contribution to ground and surface water quality and quantity.

KWF supports capacity building by raising KMWP's profile and supporting fieldwork within the functioning conservation area of the partnership, allowing KMWP to leverage staff time for greater impact. KWF was founded and granted 501(c)(3) status on 4/29/2005.

Since 2020, KMWP staff have provided albizia-related education and outreach to communities across the Ko'olau, training citizens and empowering them to establish Rapid Albizia Death (RAD) hui—community-based albizia control teams. These groups work to address existing and encroaching albizia populations in their neighborhoods. RAD members are provided with training on tree & hazard identification, as well as removal techniques. Project staff then collaborate with this hui to coordinate removal efforts and track impacts. KWF and KMWP also produce educational mailers, PSAs, and host an albizia resources page on their website. In addition to addressing this dangerous invasive tree in an urban setting, RAD efforts also generate support for watershed conservation actions and serve as an effective way to inform the public about invasive species removal in general.

2. The goals and objectives related to the request;

BACKGROUND ON ALBIZIA AND HAZARDS

Albizia (*Falcataria falcata*) was introduced to Hawai'i as part of early forestry efforts in 1917. It is one of the fastest-growing trees in the world, with a growth rate of up to 15 ft/year eventually reaching over 100 feet tall. Since it is a pioneer species—an organism that is the first to colonize newly created environments or disturbed habitats (including urban landscapes). Due to its rapid growth rate the wood is brittle, making it prone to suddenly shedding limbs and complete structural failure. This translates to the tree dropping limbs and/or the trunk breaking without cause or warning. Both scenarios present immediate danger to the life and health of people that live in their shadow. Additionally, it poses an equal threat to critical infrastructure. As such, albizia poses a major threat to the State as a whole.

This tree costs utility companies millions of dollars annually in repairs and maintenance, as branches frequently damage electrical lines and block roadways. During tropical storms and high wind events, albizia can easily exacerbate damage to local communities. This was made evident during Hurricane Iselle in 2014 when hundreds of large albizia trees completely cut off access and utilities to the rural community of Puna (**Figure 1**). First responders could not use the roads for weeks and residents were without power for months.

From a scientific perspective this species is considered a habitat modifying organism—a species that creates new habitat, alters resource availability, and modifies physical environmental conditions. Albizia achieves this through altering the understory light profile and nitrogen levels within the soil. The longer the trees remain unchecked, the greater the risk of native vegetation being negatively affected by both dense shade and the recruitment of other low-light, nitrogenloving invasive species like mule's foot fern and miconia.




Figure 2: Areas of albizia-dominate canopy (in yellow) on O'ahu that indicate a heavy infestation. Note the highlighted invasion in the back of Mānoa Valley.

On O'ahu, albizia is not being addressed to the degree necessary to prevent the spread of this species through urban and agricultural landscapes (**Figure 2**). Trees are rapidly establishing along major thoroughfares, urban stream corridors, and on residential/agricultural properties. Approximately 20,000 acres are considered infested with albizia on O'ahu. Community members often cannot identify young albizia before it's too late - due to the rapid growth of these trees, they quickly become a prohibitively financial burden for individual property owners to remove, allowing many to reach sizes that are hazardous to their surroundings.

With the finalization of the Hawaii Invasive Species Council's (HISC) strategic plan for albizia management in 2018, initiatives through the Honolulu Board of Water Supply (BWS), and recent outreach by the KMWP and KWF, there is an increased focus on albizia related projects. RAD efforts in Mānoa, being the pilot community for KMWP's albizia outreach program, are the longest running. KMWP has collaborated with the local non-profit Mālama Mānoa (MM) to coordinate presentations, workshops, and RAD Hui workdays to address albizia along Mānoa Stream. Currently, the Mānoa RAD Hui conducts an annual sweep where participants identify and remove albizia seedlings along Mānoa stream (**Figure 3**). All adjacent homeowners are notified of the workday and sign an access permission form in support of these activities. To-date over 2,400 albizia trees have been removed from the stream, preventing future hazards..

REMOVAL OF HAZARD ALBIZIA FROM MANOA STREAM

The long-term vision for Mānoa Stream is to locally eradicate albizia, thereby increasing public safety and community resilience. A goal to help achieve this vision is the removal of hazardous albizia from the Mānoa Stream corridor. Hazard trees are taller than 15 feet and grow within 1.5 times their height from

public infrastructure/private structures (e.g. roads, power lines, homes, etc.). Using this standard, 57 hazard trees have been identified in the stream. These trees, which are found along a 1.1-mile section of a residential portion of the stream, have been mapped by KMWP, with assistance from the Mānoa RAD Hui. In this application we are seeking funding to contract certified and insured arborists to remove all identified hazard trees from this corridor with permission from property owners, to be obtained by KMWP staff. Finally, annual Mānoa RAD Hui surveys will eradicate any seedlings to ensure no seedlings grow to replace these hazard trees.

3. The public purpose and need to be served;

The project focuses on addressing negative impacts to communities caused by albizia and will tackle compounding issues using an approach with simple, long-term sustainability. This project directly contributes to advancing the 10-year forest action plan, the Hawaii Strategic Plan for Albizia Management, and is in alignment with the goals of the State of Hawai'i—Kaulunani Urban and Community Forestry Program. This proposal addresses the need to increase community resilience by removing hazard trees that pose risks to schools, homes, and critical infrastructure (**Figure 4**).

4. Describe the target population to be served; and

The target population to be served is the Mānoa Valley community—to include the businesses, schools, and other public institutions that are located in the valley. There are over 48,000 residents living in Mānoa that will benefit from flood risk mitigation as well as over 20,000 faculty, staff, and students that rely on the infrastructure of the University of Hawai'i at Mānoa campus.

5. Describe the geographic coverage.




Figure 5: The geographic extent of the proposed project. The numeral next to each point represents the total number of hazard trees in that location.

The 57 mapped hazard trees along 1.1 miles of the stream (**Figure 5**), starting from Waakaua Place and ending at Mānoa District Park, negatively impact approximately 41 property owners, four City and County of Honolulu land parcel TMKs, and one State of Hawai'i parcel TMK.

III. Service Summary and Outcomes

The scope of work is to remove the 57 albizia hazard trees along Mānoa Stream (**Figure 5**). All landowners with hazard trees on their property will be notified to receive permission to access and remove these tree(s) by a contracted, certified, and insured arborist. KWF will work with KMWP project staff and community stakeholders in Mānoa to facilitate the removal of these trees.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

Q1: Announce to landowners with hazard trees along Mānoa Stream that the project is starting. Consult with certified arborists to assess how many trees can be removed. Prioritize hazard trees to remove, addressing the highest hazard trees first. Obtain signed permission with land owners. Arborists begin removing albizia hazard trees.

Q2: Arborists continue removing albizia hazard trees.

Q3: Arborists continue removing albizia hazard trees.

Q4: Wrap up removal of hazard trees. Monitor for regrowth from hazard albizia trees. Collect and report on results.

Results will be evaluated by the number of trees removed versus the number of identified trees (57). Long-term monitoring will be conducted via RAD Hui stream sweeps as described above, looking for any signs of regrowth of hazard trees controlled by arborists and controlling them.

At KMWP, JC directed major planning, budgetary, and staffing decisions. JC also worked with funding agencies to identify and obtain financial support for projects. The KMWP Operations Coordinator—Dylan Davis interfaces directly with the KMWP field team and outreach program to ensure that all project deliverables and reports are completed on time and to the highest standard. Dylan brings over 7 years of progressive land management experience and a track record of successful project completion. Since 2022, KWF and KMWP have collaborated with MM and the Manoa RAD Hui to monitor albizia presence in the valley, specifically along the stream corridor. KWF and the KMWP collaborate to ensure that all deliverables and reporting requirements are met. KMWP's Rapid Albizia Death (RAD) program curates a list of certified arborists that have experience with albizia removal, including large hazard trees. These certified arborists are specialized professionals that have the skills and resources to safely remove all sizes of trees in even the most precarious settings. 
