Special Olympics Hawaii Inc. (SOHI) is a non-profit 501(c)(3) organization dedicated to transforming the lives of people with intellectual disabilities (ID) through programming in sports, health, education, and community building. Special Olympics Hawaii was founded in 1968.

SOHI's mission is to provide year round sports training and athletic competition in a variety of Olympic-type sports for children and adults with intellectual disabilities, giving them continuing opportunities to develop physical fitness, demonstrate courage, experience joy, and participate in a sharing of gifts, skills, and friendship with their families, other Special Olympics athletes, and the community.

Our competitive program for athletes ages 8 and over serves 2600 athletes and unified partners (individuals without ID who compete alongside athletes with ID). Our Young Athlete Program serves over 1000 2-7 year olds annually. In addition to sports, our initiatives include:

- A Young Athlete Program that introduces children with ID ages 2-7 to sports skills, movement, and socialization and provides parents and teachers with a curriculum
- Unified Champion Schools for K-12 schools promoting social inclusion by bringing together young people with and without disabilities on unified sports teams, through inclusive student clubs, together in school or community-wide initiatives, and by fostering youth leadership
- Leadership Conferences for athletes, volunteers and family members
- An O'hana Task Force offering support, education, and a voice to our families
- A Toastmaster's Club, Global Messenger Training, and an Athlete Leadership Council
- Healthy Community status as accredited by Special Olympics Inc., for work in creating and training a network of care givers for those with ID, for providing Healthy Athlete exams in 7 disciplines, physician referrals with follow up, health education, and free medicals
- · Holo Holo walking clubs, fitness and conditioning training

These initiatives and SOHI's in-depth sports programs encourage self-sufficiency and teaches individuals with intellectual disabilities the skills to achieve healthy, meaningful lifestyles. Year-round programming builds community resilience for athletes, families, coaches, and volunteers.

2. The goals and objectives related to the request;

This request is to provide funding for sports training and competitions for individuals with intellectual disabilities. SOHI offers over 40 competitions and 3 State Games annually with weekly practices and training throughout the State of Hawaii.

The three primary sports seasons include spring and early summer competitions with the sports of softball, track and field, powerlifting, and swimming with a final State Summer Games held in June. Summer sports include soccer and bocce with a competition held in August, called the Aukake Classic. The fall season includes bocce, basketball, and bowling with the Holiday Classic State Games held in November. Additionally, SOHI provides an early Spring Season of League Play in Flag Football with local competitions.

Grant Request Goals & Objectives:

1. 2600 athletes and unified partners will participate in sports training and competition.

- 2. 9 sports will be provided for training and competitions, in their respective seasons. Sports include: Powerlifting, Track & Field, Swimming, Softball, Bocce, Soccer, Bowling, Basketball, and Flag Football.
- 3. 40 competitions and 3 State Games will be held. For a typically underserved population the opportunity to achieve personal bests and/or experience team sports creates meaningful life experiences.
- 4. 65 schools will participate in sports training, competitions, and recreational sports programming. Unified participation in sports in middle and high schools creates understanding, acceptance, and inclusion beyond the playing field.
- 5. 2100 volunteer opportunities will be filled. As volunteers are exposed to individuals with ID they gain perspective, develop respect for the athletes, and alter their perceptions about the abilities of those with ID.
- 6. 325 family members will attend competitions and complete the online family registration annually. Participation in Special Olympics can benefit the overall family dynamic as families support each other and see their athlete engaged and growing. Special Olympics Inc. estimates that each athlete has the support of 3 family members on average, however many do not officially register.
- 7. 175 coaches will train athletes and unified partners for fitness and competitions. Whether team or individual sports SOHI certified coaches training and expertise leads to athlete growth and wellbeing.

### 3. The public purpose and need to be served;

In Hawaii, 75% of individuals with intellectual disabilities qualify as low-moderate income according to HUD guidelines. By definition, people with ID are categorically needy and are eligible, by reason of their disability and low income earning potential, to qualify for government assistance. Statistics from the Hawaii State Department of Health report that a minimum of 15,000 children and adults in Hawaii with intellectual disabilities meet SOHI's eligibility requirements.

Sports and fitness programs are difficult for people with ID to access and afford. Most facilities, gyms, and sports organizations either cannot or are not willing to accommodate people with special needs. The benefits of physical activity, and sports specifically, are well documented and include improved cardiovascular health, decreased risk of obesity, strengthening bones and muscles, improved physical, psychological, and social health.

SOHI provides a safe, trusted environment for individuals with ID and their families. We encourage athletes to be independent, confident, to advocate for themselves, and to contribute to the community. To achieve these goals we conduct programming and activities that address numerous opportunities for athlete growth and accomplishment. SOHI programs are provided without the burden of costly services that would be paid for through a government body or not offered at all.

- 4. Describe the target population to be served; SOHI's target population is individuals with intellectual disabilities of all ages. SOHI's services are 100% free to all participants including athletes with ID, unified partners, family members, coaches and volunteers. This extended community directly supports the needs of our target population and are essential to SOHI programs. In addition, as of 2023, SOHI's Unified Champion Schools initiative is active in 70 schools including 29 Title 1 Schools with 525 students participating in recreation and sports activities in an inclusionary environment.

   Special Olympics Hawaii provides sports training and competitions on the islands of Oahu, Maui, Kauai, Hawaii Island, and Molokai.

### 1. Necessary Skills and Experience

For 55 years, SOHI has provided extensive, quality, year-round sports training and athletic competitions, health and youth initiatives, leadership programming, Ohana support and engagement, volunteerism ranging from dedicated, long-term coaches to annual day of partners in an inclusive setting for children and adults with ID. SOHI's programs and services foster an increased understanding and integration of people with intellectual disabilities in the greater community, advancing self-efficacy for the athletes.

SOHI met key indicators of success in the past 3 years. In 2023 SOHI held 3 State Games with 40 competitions serving 2000 athletes and partners. In 2022, despite lingering Covid fears, SOHI held 3 State Games, and 25 competitions serving 1400 athletes and partners. In 2020 and 2021 all in person competitions had to be cancelled due to Covid, however, SOHI provided ongoing virtual programming and virtual competitions for our community. Prior to the Covid years, SOHI consistently held 3 State Games with over 45 competitions for 3000 athletes and partners.

On the national level, the excellence of our programs is illustrated by Special Olympics being named the Top Disability Organization in the Harris Poll Annual EquiTrend Study. This study was based on consumer responses of the strongest brands in nearly 100 categories across multiple industries, measuring an organization's brand health over time based on familiarity, quality, and purchase consideration to determine equity rating for each brand.

SOHI has maintained prestigious worldwide designation of a Special Olympics Healthy Community, the highest level of Special Olympics Health recognition for programs that have elevated their Health work to broaden access to quality health care and year round health, wellness, and fitness opportunities in their community. As a recognized Healthy Community, SOHI continues to make strides in Hawaii toward equitable access to quality health care education and services throughout communities for people with ID.

Charity Navigator has scored SOHI at 100% with a 4 star rating, signifying that the organization achieves or exceeds industry standards. SOHI adheres to sector best practices and is accredited by Special Olympics, Inc. annually, ensuring that programs maintain the highest level of standards for its participants and families.

### 2. Facilities

Special Olympics Hawaii works with the University of Hawaii, Kaiser High School, Waiau District Park, Joint Base Pearl Harbor Hickam, and Marine Corp Base Kaneohe to secure facilities for State Competitions. SOHI secures facilities far in advance of State Games and competitions and maintains relationships throughout the year to ensure facilities are available for our competitions and State Games.

SOHI works with the numerous Department of Education schools and County Parks to secure training and competition sites for practices and area/regional competitions. SOHI can now also use the field, and soon, the outdoor play court, at our new facility in Kapolei to accommodate some local competitions

### VI. Personnel: Project Organization and Staffing

### 1. Proposed Staffing, Staff Qualifications, Supervision and Training

SOHI has the organizational skills, extensive sports training, experience, and knowledge to fulfill the grant goals and scope of work. Our CEO and Senior Vice President have trained Special Olympic National and World Games coaches and have stepped up to pilot programs such as Healthy Communities and Toastmasters. Hawaii is well respected in the Special Olympics community and our Summer Games is a flagship for other state programs.

Senior Vice President Nip (Margaret) Ho, with SOHI since 1996, will oversee all sports training and competitions, Area Director staff and Management Teams. Nip was a Special Education teacher for 6 years and is certified for Special Education Birth – 12th Grade, regular Elementary Education and Physical Education. She served as the Area Director of Wyoming for 6 years prior to joining SOHI. Nip has managed 80 State Games and innumerable competitions. Nip reports to SOHI's CEO and Board of Directors.

Cindy Ujimori, our Vice President of Community Outreach since 2005, will oversee volunteer recruitment, manage housing and transportation for all State Games, and recruit sponsors for State Games. She runs logistics at State Games for the Law Enforcement Torch Run in addition to assisting with Opening Ceremonies, hospitality, and other multiple venues. ### Regional Directors:

SOHI's 2 Regional Directors oversee multiple Area programs and Staff. The Maui County Area Director oversees the Neighbor Islands including Maui, Molokai, Kauai, and Hawaii. The Oahu Area Director oversees Leeward, Windward, and Central Oahu programs. Their key responsibility is to ensure that quality Special Olympics sports training programs and athletic competition events are available to all eligible individuals with ID in a specific geographic location. AD's conduct area and regional competitions, recruit new athletes, manage athlete registration, medical records, competition results, and volunteer screening. They create and maintain relationships with coaches, heads of delegations, and family members holding frequent meetings and communications to ensure quality programming. Regional Directors report to the Senior Vice President and CEO.

SOHI's Senior Staff have been with the organization for over 75 years bringing institutional and logistical knowledge combined with direct, hands on experience and an educated perspective regarding the needs and abilities of individuals with ID.

Special Olympics Hawaii depends on grants, individual contributions, support from local businesses, corporate sponsorships and partnerships, and fundraisers to sustain programming. SOHI will always request funding from our community because we are not able to raise funds outside of the State of Hawaii, as each state Special Olympics organization is entitled to their own region. Special Olympics Incorporated handles all federal funding, and, as they propose new programming such as health initiatives and unified sports for which funding is available, SOHI is always among the first to jump onboard and provide innovative, updated services to our athletes.

SOHI is quite effective in acquiring and maintaining sponsors. Over the years, we have been successful in increasing the sponsorship levels of several longtime supporters to become our Mission Partners, Year Round Partners, and Event Sponsors. We hold a series of historically successful fundraisers annually that are recognized by the public, many of whom look forward to participating annually. These include Cheer for Champions, Over the Edge, Badges and Buckets, and Tip a Cop. We continuously review, transform, and research new revenue sources with the assistance of our Board of Directors, the Law Enforcement Torch Run, and our strong Development Team.

Post Covid there have been many changes in contributions and in kind donations. Corporations have redesigned, and in many cases, limited their giving. In addition, inflation has been a factor in increased expenses for sports programming including shirt costs, housing for athletes at games, and transportation for event participants. SOHI continues to employ a diverse revenue plan to meet all program needs.


