We are Certified facilitators who have been gifted a location to implement effective tools for mental health healing and building positive emotional resources for brighter futures with a focus on children 11-17 yrs old who are survivors of trauma (based on the ACES study) Sexual abuse, Sex Trafficking, physical and emotional abuse.

We are in need of funding for: permits for a Major SMA to build an Ag Exempt Barn, Stalls, covered arena, required surveys and consultants, and the architect to move the project fonward. (Labor and materials required) a portion of the operating budget.

We opened for services in 2023 with very limited infrastructure and need desperately shaded areas and a classroom for clients and a a paved road over the existing road to the facilty to provide our clients the full potential for healing in a protected space.

In August of 2023 we opened our program up to all of Maui county residents due to the wildfire disaster and have seen over 550 clients we need to build a better operating space. Due to the Maui Wild Fires we are requesting the state to keep our services open to the residents and outer Maui County Islands Lanai and Molokai

II. Background and Summary

A. Overview and Background

The Spirit Horse Ranch is a Hawaii-based nonprofit organization operating through a Fiscal Sponsorship with Players Philanthropy Fund, a Maryland charitable trust recognized by the IRS as a tax exempt 501(c)(3) public charity. Our main mission is to connect adolescent and teen survivors trauma and abuse to their inner warrior, reigniting the light in their eyes through the healing energy of equine-facilitated learning, and eventually a gardening and art therapy program in the foothills of Haleakala. Since August 11, 2023 The Spirit Horse Ranch opened it's program to all Maui county residents and has served a total of 533 individual equine therapy sessions to heal the community: 62.5% Adults 18 – 80 yrs of age and 37.5% children 1-17Yrs of age.

The Spirit Horse Ranch is dedicated to healing, fueled by the right team, facility, and curriculum to ensure a safe environment. Through equine assisted learning, artistic expression and organic gardening in the healing environment of the slopes of Haleakalä, The Spirit Horse Ranch seeks to identify and nurture the warrior spirit of all survivors of trauma and abuse, enabling them to find the strength to achieve a positive, productive, beautiful

future.

The Spirit Horse Ranch believes in collaboration, integration, and learning from those who came before us. Through collaboration with the most revered practitioners, we seek to elevate our ability to create lasting change for those who come to the Ranch for healing. Our Equine Assisted Learning (EAL) provides a healing environment utilizing equine activities; interactive horse and ranch activities and hands-on horse care, transforming the youth into wranglers. The natural ability of horses to pick up on human emotional expressions enhances the effectiveness of EAL. Patient, perceptive, and attuned to fear, anger, agitation, and despair, horses are attune to human moods in a nonjudgmental way. As the horse and person bond, a healthy connection via self-awareness grows resulting in emotional healing.

In addition to our EAL programs, we also offer programs in collaboration with HeartMath Institute. Based upon theories integrated into the practices of Stanford Medicine, Kaiser Permanente, Cedars Sinai, NASA and the Department of Veterans Affairs for over 25 years, HeartMath Institute has been researching the heart-brain connection and learning how the heart influences our perceptions, emotions, intuition and health. The program helps kids tap into the power and intelligence of their heart which awakens them to the best version of themselves. Tuning into the heart's wisdom creates a profound shift within that helps children approach situations with more emotional balance, compassion, clarity and personal confidence.

B. Goals and Objectives

Founded in 2021, The Spirit Horse Ranch is a certified Equine Assisted Learning (EAL) and Trauma Informed Care Equine facility. The Spirit Horse Ranch has been generously provided

with a location, and are seeking infrastructure (capitol) and operating support. The facility is designed to teach our children and adults tools for trauma and mental wellness, to rebuild positive emotional resources for a brighter future. Our programs and services are uniquely tailored to those who are survivors of trauma (based on ACES), sexual abuse, sex trafficking, physical and emotional abuse, and child neglect disaster rapid response and stabilization.

We are seeking funding to apply for required permits, facilitate development and construction of agriculture exempt barn, barn stalls and arena, finish the roadway to our facility, and to support any required or related surveys, consultancy fees, and an architect to move our project forward. Labor and materials required.

In addition to our current programs, The Spirit Horse Ranch is spearheading two additional programs in March of 2024-2025. These programs are centered on artistic expression and organic gardening. The fine arts, such as painting and music, contribute to core determinants of health; playing a critical role in health promotion; helping to prevent the onset of mental illness and age-related physical decline; supporting the treatment or management of mental illness, and non communicable diseases and neurological disorders.

The Spirit Horse Ranch will have a greenhouse for youth to learn to plant and grow food to support mental wellness by enabling participants to practice acceptance, move beyond perfectionism, develop a growth mindset, connect with others, connect to the world outside, become one with nature, be present in the moment, exercise, reduce stress, eat healthfully, develop a sense of teamwork, and gain confidence, through the knowledge that their actions help to sustain life.

C. Public Purpose, Need, and Target Population

The need for a haven like The Spirit Horse Ranch has never been more pressing. With Maui County in the midst of a critical mental health crisis prior to the wildfire at 32% the numbers have sky rocketed. Abuse records show in increase from 125 call a month to 500 calls a month. And nationally, 8% (an estimated 10 million) girls and 0.7% (an estimated 791 thousand) boys under age 18 have been sexually and or physically and mentally assaulted. When experiencing sexual violence as a child makes it more likely the survivor will experience re-victimization in adulthood. 30% of

adult rape victims were first assaulted before they were 18. In 2017, suicide became the second leading cause of death for people ages 10 through 24.

With the mental health of our children already in a tenuous space; then came the global pandemic. COVID-19 and lockdown brought a sense of fear and anxiety to people globally, leading to short term as well as long term psychosocial and mental health implications for children and adolescents. Suicidal idealization is at an all-time high. Our children are suffering and the long-term impact is still unknown.

Additionally, economic adversity (such as job loss, unemployment, or underemployment) has been observed as a precursor to harsh parenting, and a risk factor for psychological maltreatment and physical abuse. Lockdowns, school closures and movement restrictions have left far too many children stuck with their abusers, without the safe space that school would normally offer. Our vulnerable children are even more at risk in these challenging times. The need for a haven like The Spirit Horse Ranch has never been more pressing.

D. Geographic Scope

The Spirit Horse Ranch founded by Paige Deponte and Triple L Ranch will be housed on Triple L Ranch. Leveraging acreage, TLR will ensure solitude required for the Spirit Horse Ranch programming in a healing environment specifically curated to support the beneficiaries. Additionally, the program serves as a sanctuary for the retired Triple L Ranch Horses to love and share their love with our clients.

Established in 1947, the DePonte family operates Triple L Ranch, one of the few remaining Paniolo working cattle ranches on Maui. The ranch is located in verdant, pristine, sacred, and undeveloped country on the southwest side of Haleakalä, with a combined 132 acres of land.

III. Service Summary and Outcomes

A. Scope of Work, Tasks, and Responsibilities

The Spirit Horse Ranch is a certified Equine Assisted Learning (EAL) and Trauma Informed Care Equine facility. The Spirit Horse Ranch has been generously provided with a location, as and are seeking infrastructure and operating support. The facility is designed to teach our children and adults tools for trauma and mental wellness, to rebuild positive emotional resources for a brighter future. Our programs and services are uniquely tailored to children, ages 11-17, and adults who are survivors of trauma (based on ACES), sexual abuse, sex trafficking, physical and emotional abuse, and child neglect and disasters such as the Maui wildfires.

In addition to our current programs, The Spirit Horse Ranch is spearheading two additional programs in March of 2023. These programs are centered on artistic expression and organic gardening. The fine arts, such as painting and music, contribute to core determinants of health; playing a critical role in health promotion; helping to prevent the onset of mental illness and age-related physical decline; supporting the treatment or management of mental illness, and noncommunicable diseases and neurological disorders.

The Spirit Horse Ranch will have a greenhouse for youth to learn to plant and grow food to support mental wellness by enabling participants to practice acceptance, move beyond perfectionism, develop a growth mindset, connect with others, connect to the world outside, become one with nature, be present in the moment, exercise, reduce stress, eat healthfully, develop a sense of teamwork, and gain confidence, through the knowledge that their actions help to sustain life.

Ms. Paige DePonte, Project Director and Founder of The Spirit Horse Ranch, will be responsible for coordination of onsite outreach. She will oversee every aspect of the project, work closely with partners and personnel to ensure maximum benefit to program participants, youth, and families. We estimate a population in excess of 2,500 within a one mile radius of our location. And 176,000 within a 50 mile radius. Ms. DePonte will work diligently with partners to ensure maximum benefit for program participants, youth, teens, adolescents and adults across all formats.

B. Annual Timeline

Phase I: Program Development: 1st quarter 2023

MiJestones and Expected Outcomes

- We have established a fiduciary partnership with Players Philanthropy Fund and have built our leadership team including Advisory Board, legal counsel and marketing team;
- Completed Certifications of Equine Assisted Learning, Heartmath and as Natural Lifemanship Practitioners and Brainspotting Practioners.
- Provided 534 individuals services in 2023.
- Completed two Round Pen and small arena areas for Programs EAL;
- Needs are to secure funding to build a shelter classroom and shaded areas for the children's equine assisted learning program;
- Secure funding for fencing the additional 30 x 50 pen for EAL activities; and
- Secure funding to hire a professional architect and team to move forward with the County and State process for completing our full build out planned for 2024-25.

Phase II: Pre-Construction: 1st-2nd quarter 2022

Milestones and Expected Outcomes

- Finalize designs with architect; and
- Meet with Maui County Planning with plans for Agriculture Buildings (e.g. barn, stables, and riding arena)

Phase III: Barn Construction: 2nd-4th quarter 2024

Milestones and Expected Outcomes

- Begin barn construction, stable areas, and a riding arena, contingent upon available funding; and
- Build out barn, more round pens, EAL covered arena, horse stables, art and HeartMath classroom, gardening enclosures, road, parking, solar systems, and water catchment.

C. Project Monitoring and Evaluation

Our plan for project monitoring and evaluation will include data collection and analysis by offering both pre and post-program surveys to be completed by children, parents, and project

partners. All sessions are computer generated as well as sessions and program info to provide accurate data collection. Data will be collected, monitored, and disseminated both internally and externally, and will be used to evaluate improvements across a multitude of dimensions, including youth engagement, mental health rates and assessments, and participation, among others. Outcomes and metrics will also be used continually to inform ongoing programmatic improvements.

Measurement of program outcomes will be used continually to monitor and inform ongoing programmatic improvements. The data collected will be analyzed and reviewed by a project committee consisting of a member of each project partner or organization and The Spirit Horse Ranch representatives and administrative personnel. The results of the analysis will be used to measure project performance in achieving stated outcomes and make program and training adjustments to better align with projected goals as recommended, by the committee. To date we have secured a 219% positive result outcome.

Program information will be disseminated both internally and amongst project stakeholders via committee meetings, emails, virtual meetings, telephone, and memos. Information shared publicly will be made available upon request in written format and shared via email, social media, marketing, and other outreach materials. Data will be screened for appropriate delivery methods.

D. Plan for Outcome-Based Reporting

Outreach performance outcomes will be measured by the number of youth and project participants engaged during programming, and the number of targeted age groups or other targeted community demographics enrolled and participating in the program. Training and support performance will be assessed based on the number of participants in participation, reported youth engagement, mental health rates and assessments, participation, and a variety of other metrics.

Outcome-based reporting, assessment, evaluation of project results, and expected outcomes will include data collection and analysis by offering both pre and post-program surveys to be completed by children, parents, and project partners. The Spirit Horse Ranch is seeking capital funding to support further facilities development initiatives. The ranch is currently located in verdant, pristine, sacred, and undeveloped country on the southwest side of Haleakalä, with a combined 132 acres of land.

VI. Personnel: Project Organization and Staffing

A. Personnel, Competence, Supervision, and Training

Staffing patterns at The Spirit Horse Ranch include twelve paid personnel. This includes two facilitators, four equine professional assistants, one barn manager, one farmhand, an assistant to the director, our gardening program director, managing director, and Ms. Paige DePonte, our Founder and Executive Director.

The proposed service capacity is approximately 400 youth and adolescents. This includes an estimated 100 children who are currently on a waiting list (two agencies) for our innovative programs, along with other interested parties. We will offer 5 program days over the course of a 4-week program, with an estimated 40 children per week, every four weeks (eleven sessions per year). This equates to an estimated 400 individuals served per year. Our impact reaches not just the youth and adolescents served, but extends to their families and other support systems.
