# I. Public Purpose and Need to be Addressed

Aloha Dance Studio has served as a sanctuary for many students, offering a home away from home for those in need of a safe environment or struggling with mental health issues.

Motivated by the aspiration to amplify their impact, Tiffany and Seth founded Thrive With Movement with the goal of reaching a wider audience of children and youth on the island of Kauai. We are excited to extend scholarships to low-income families, at-risk children, and students showing promise in the performing arts.
