3. Public Purpose

Pursuant to Section 42F-102, Hawaii Revised Statutes, this proposal will be used for the public purpose of expanding access to primary health care services for low income and high-risk populations in the rural district of Puna, on Hawaii Island. West Hawaii Community Health Center (WHCHC), doing business as Hawaii Island Community Health Center (HICHC), is a Federally Qualified Community Health Center (FQHC), with 501(c)3 nonprofit status. HICHC provides preventive care, including primary medical, oral health, and mental health/substance use disorder treatment. HICHC provides essential health care services to medically underserved and vulnerable populations, including the uninsured and those living below the poverty level. As a FQHC we provide primary care services to everyone, regardless of their ability to pay. With this FY 2025 GIA proposal, HICHC is requesting public funds (\$1,020,000) for the purpose of completing the architecture and engineering for a new primary health center in the medically underserved rural district of Puna, on Hawaii Island. The new health care facility will be built in Kea`au and will be a hub serving four communities including Kea`au, Kurtistown, Mountain View, and Pahoa (zip codes 96749, 96760, 96771, and 96778). The target population to be served by this proposal includes the entire population of these communities, with special focus on providing a medical safety net for low income and high-risk populations.

Ensuring access to healthcare services for low-income and vulnerable populations is an indispensable investment that reduces healthcare costs for county, state, and federal governments. Beyond the inherent moral obligation to uphold the right to health for all citizens, this commitment is a farsighted strategy that significantly reduces long-term costs while fostering numerous social benefits. By providing timely and preventive healthcare interventions, governments mitigate the burden of untreated illnesses that often escalate into costly emergency room visits and hospitalizations. This proactive approach not only saves financial resources but also elevates the overall health of the population, leading to a more productive and engaged society. Moreover, accessible healthcare acts as a catalyst for economic growth, breaking the shackles of inequality and empowering individuals to actively participate in the workforce. It fosters resilience in communities, strengthens social bonds, and shapes a future where the well-being of every citizen is prioritized. In essence, investing in accessible healthcare for low-income and vulnerable populations is a wise, compassionate, and economically sound decision that reaps dividends in both fiscal responsibility and the holistic flourishing of our communities.

II. BACKGROUND AND SUMMARY

1. Applicant's Background

On July 1, 2022, West Hawaii Community Health Center (based in Kailua-Kona), and Bay Clinic (based in Hilo), merged to form Hawaii Island Community Health Center (HICHC). West Hawaii Community Health Center is the legally surviving entity and West Hawaii Community Health Center's EIN (20-0495394) remains for this organization. WHCHC has 18 years' experience serving the west side of Hawaii Island, and Bay Clinic has 40 years' experience providing primary care on the east side of Hawaii Island, with a combined total of 58 years' experience providing health care services to our Hawaii Island communities.

HICHC provides primary medical, dental, and behavioral health care throughout a service area that spans 20 zip codes including 96738, 96740, 96725, 96750, 96726, 96704, 96737, 96772, 96777, 96785, 96778, 96771, 96760, 96749, 96720, 96781, 96783, 96710, 96728, and 96773. This service area is home to 175,734 people, 38,072 (or 22%) of whom are registered HICHC patients.

HICHC is a Federally Qualified Community Health Center (FQHC) and as a FQHC we improve the health and well-being of underserved communities, while empowering people to become actively involved in solving issues unique to their needs and communities. We are innovators, healers, and problem solvers who reach beyond the constraints of the conventional healthcare delivery system. We focus on preventive care by addressing the social determinants that may cause poor health such as diet, nutrition, mental illness, homelessness, and substance use disorder. In addition to providing primary health care services, we offer enabling services to assist patients with specific barriers to care including translation services, insurance enrollment, referrals to specialists, and access to other social services. We provide these services regardless of the patient's ability to pay. We provide quality healthcare services to all and do not discriminate on the basis of race, color, national origin, age, disability, religion, or sex (including pregnancy, sexual orientation, and gender identity).

The mission of HICHC is to promote lifelong health and wellness through quality healthcare that is comprehensive, integrated, culturally responsive, and accessible to all. HICHC has a workforce of 440 employees, including 63 providers (medical, dental, and behavioral health).

HICHC has a long history of financial, organizational, and quality clinical care excellence. In 2022 we received four federal HRSA quality recognition awards including the National Quality Leader in Behavioral Health Award which ranks our Behavioral Health Department in the top 1-2% of all Federally Qualified Health Centers, exceeding national benchmarks for clinical quality measures. HICHC also received the Quality Health Leader Award-Bronze level, ranking HICHC in the top 21-30% of all FQHC's nationally for achieving the best overall clinical quality measure (CQM) performance among all health centers. In addition, HICHC received the Advancing Health Information Technology for Quality Award for optimizing health information technology services, advancing telehealth, and improving patient engagement, interoperability, and the collection of social determinants of health to increase access to care and advancing quality care. HICHC has Patient Centered Medical Home (PCHM) recognition for all our clinics across Hawaii Island. We carry this standard of excellence forward in the implementation of all programs and projects, including the planning and construction of this new medical facility in Kea`au.

2. Project Goals and Objectives Timeline

Hawaii Island Community Health Center received a FY 2024 State Legislature GIA award of (\$400,000) for this project to complete the design, program and schematic phase of this CIP project. HICHC is now requesting FY 2025 GIA capital improvement funds totaling (\$1,020,000) to complete the architecture and engineering phase of this project. The goals and objectives below describe the intentions of this CIP project which will result in the completion of a new 15,000 sf healthcare facility in the rural district of Puna, on Hawaii Island.

GOAL: Provide expanded access to primary health care (medical, behavioral health, and enabling services) for residents of the rural district of Puna, by completing the designing/architecture and engineering phase for a new community health center in Kea`au. The objectives below describe what will be accomplished during this architecture and engineering phase of the project.

3. Public Purpose and Need to be Served

The U.S. Department of Health and Human Service has designated Hawaii Island a Dental Care Health Professional Shortage Area (HPSA), a Mental Health Professional Shortage Area, a Primary Care Professional Shortage Area, and a Medically Underserved Population (MUP). Independently these shortage designations are indicative of a great need; combined they specify monumental need especially for high-risk populations. A recent Community First report, published in April 2022 titled "Access to Care", surveyed Hawaii Island health care providers and found that (47%) of Hawaii Island providers were imminently retiring or leaving medicine; (44%) were moving to the mainland; and (49%) said they were reducing their hours. The report concluded that Hawaii Island's health care provider shortage may worsen. Compared to the rest of the state, Hawaii Island has a lower per capita income, higher prevalence of uninsured and impoverished adults, and higher rates of public assistance and homelessness, exacerbating the need.

US Census data indicates that population of Pahoa, Kea`au, Kurtistown and Mountain View is 43,297 people, with 17,397 people being low-income, and 30% receiving Medicaid. Other demographic data on the region shows that 21% of the population has one or more disability, 17% of the population is veterans, 19% is over the age of 65, and 70% identifies as a member of a racial/ethnic minority. In addition, 38% of adults have not seen the dentist in the past year. HRSA data shows that there are *6,747 low-income people living in Puna not currently receiving health care services* (UDS MAPPER; Data Report ZCAT 96749, 96760, 96771, 96778).

HICHC currently operates a small medical and dental clinic in Kea'au serving 4,150 medical patients, and 2,693 dental patients. Once the new 15,000 sf Kea'au Family Health Center is open, HICHC will use the current location for dental care only and the new facility for medical, behavioral health and enabling services. This new Kea'au Family Health Center will increase our service capacity to annually serve 11,000 patients. The new facility will allow us to continue serving our current 4,150 patients, along with a projected additional 6,850 new patients. The new 15,000 sf Kea'au Family Health Center facility will include 20 exam rooms, with enough space to accommodate 5 primary care physicians and 3 behavioral health providers.

Healthcare is a basic need and access should be a considered a right not a privilege. To maintain a healthy community and work force, it is vital to have access to health care. This is not currently the case in the rural district of Puna (Kea'au, Kurtistown, Mt View, and Pahoa). Without access to primary care, the in-patient cost of treating these individuals rises significantly—a cost that gets transferred to the general public through higher premiums and fees and ultimately an increased tax burden. In addition,

children without health care typically have poor health status, poor school attendance, and poor academic performance. The new health clinic will expand health services and improve access to health care, improve health status, and enhance the quality of life for people in these communities.

Public Need Served Summary:

Ensuring access to healthcare services for low-income and vulnerable populations is an indispensable investment that reduces healthcare costs for county, state, and federal governments. Beyond the inherent moral obligation to uphold the right to health for all citizens, this commitment is a farsighted strategy that significantly reduces long-term costs while fostering numerous social benefits. By providing timely and preventive healthcare interventions, governments mitigate the burden of untreated illnesses that often escalate into costly emergency room visits and hospitalizations. This proactive approach not only saves financial resources but also elevates the overall health of the population, leading to a more productive and engaged society. 4. Target Population

The target population to be served by this proposal includes the entire population of Puna, with special focus on providing a medical safety net for low income and high-risk populations. HICHC provides care to anyone who walks through the doors, regardless of income or ability to pay. Our target population is the low-income, uninsured, and underinsured persons who have difficulty accessing care. The new Kea'au Family Health Center will follow the same protocol. HICHC provides a Sliding Scale Fee payment program to all patients. Depending on their income and family size, patients may pay a small fee or no payment at all, depending on their circumstances.

The typical HICHC patient accesses care 3.5 times during the year. Eighty percent of patients have incomes less than 200% of the federal poverty level. A majority of the patients identify as Native Hawaiian, Asian, Filipino, Marshallese, Hispanic, or other Pacific Islanders. Our target population for this grant is all low-income adults and children, most of whom identify as being Native Hawaiian, Spanish speaking, Micronesian, Marshallese, homeless, LGBTQ+, and/or being of more than one race/ethnicity. Our target population has over-represented health problems including poor oral health and chronic diseases including depression, substance use disorder, asthma, diabetes, and obesity.

In actual numbers, HICHC estimates this new clinic will serve 11,000 patients each year and provide 33,000 patient visits annually.


5. Geographic Service Area

This capital improvement project will serve the geographic rural district of Puna, which encompasses Kea'au, Kurtistown, Mountain View, and Pahoa (zip codes96749, 96760, 96771, and 96778). This region is highlighted in the map below.



According to US Census, this region encompasses a population of 28,099 people.

The Hawaii Island Community Health Center geographic service area covers (20) zip codes including (96738, 96740, 96725, 96750, 96726, 96704, 96737, 96772, 96777, 96785, 96778, 96771, 96760, 96749, 96720, 96781, 96783, 96710, 96728, and 96773) with a population of 175,734 people, (22%) of whom are registered HICHC patients. III. SERVICE SUMMARY AND OUTCOMES

1. Scope of Work

This request is for \$1,020,000 to complete the architectural and engineering phase a 15,000sf new healthcare facility in Kea'au. HICHC received a FY 2024 GIA award from the state legislature for (\$400,000) to be used for the initial design work on this CIP project. This FY 2025 request will continue to move the project forward. Once operational, HICHC anticipates providing primary health care service to 11,000 patients and generating 33,000 patient visits annually at this new clinic. Most individuals served will be low-income, Medicaid and/or uninsured, children and adults who live in zip codes 96749, 96760, 96778, and 96771. Operationally, this center will be self-sufficient and generate patient revenues adequate to cover all operating costs. HICHC will continue to seek support from the State of Hawaii, the County of Hawaii, and the Federal Government for this project as investing in accessible healthcare for low-income and vulnerable populations reaps dividends in both fiscal responsibility and the holistic flourishing of our communities.

2. Project Timeline

The timeline for planning, designing, building, and equipping the new Kea'au Family Health Center covers four years. Below is a summary of timeline benchmarks. 3. Quality Assurance and Evaluation

Between new construction projects and tenant improvement projects done by both Bay Clinic and West Hawaii Community Health Center, HICHC has a combined total of two new construction projects, and fourteen separate tenant improvement projects we have successfully managed. The total value of these projects exceeds \$25 million. We accomplished these CIP projects with strong planning, excellent oversight, and experienced Project Managers who monitored all aspects of the project, communicated frequently with all parties including staff, architects, contractors and subcontractors. Critical path timeline and project manager software is used to track progress and weekly meetings with key people. Clear effective communication has been used to keep our projects on time and within budget. We expect nothing less on this project.

Hawaii Island Community Health Center also has established performance improvement plans and processes for all aspects of its clinical operations. Compliance is a major focus and is incorporated into our general operations and includes regular audits of our operations. Quality and clinical key

performance indicators are identified and tracked regularly through our electronic health records and management software. Policies and procedures are in place for personnel, finance, and clinical operations. HICHC holds itself to the highest standards.

Indicators that the organization monitors for operational performance include:

- <u>Patient Access</u>—Panel size, appointment waiting times, cycle time in the clinic.
- Best Practices—Patient care outcomes especially for chronic diseases.
- <u>Patient Safety</u>—OSHA regulations as relates to blood borne pathogens, use of medical abbreviations, patient identifiers and infectious disease control.
- <u>Viability</u>—Billing, collection, reimbursement, and coding compliance.
- Leadership—Overall patient satisfaction, staff satisfaction, and employee turnover rates.

The Kea'au Family Health Center will be staffed with 5 primary care providers, and 3 behavioral health specialists, as well as nursing and other support staff such as a care coordinator, case manager, eligibility, and outreach workers. All professional staff will be fully credentialed and certified.

Supervision of these staff will fall under the established management structure of the organization, with onsite clinical management given to a site supervisor. HICHC has regular staff department meetings and weekly senior leadership meetings. Training is made available to all staff and all new staff receive an initial orientation to the organization. Clinical staff also receives two weeks of clinical orientation from the Medical Director and Director of Nursing. In addition, HICHC management staff (IT, HR, finance, clinical quality, and nursing) will provide necessary supervision and on-going training and support to ensure all processes and workflows are standardized throughout the system. This is standard operating practice throughout the organization.

The organization is governed by a Board of Directors, a majority of whom are users of the clinic's services. The Board has delegated responsibility for day-to-day operations to the President/CEO.
