**Annual Report to the Hawaii Legislature on the State Highway Enforcement Program**

Introduction:

Section 291C-111.5(c), Hawaii Revised Statutes (HRS) requires the Department of Transportation (DOT) to report annually on the status and progress of the state highway enforcement program, including all moneys deposited into and expended from the State Highway Fund.

**Surcharge**

For fiscal year 2023 (July 1, 2022 – June 30, 2023), the total surcharge amount collected statewide was \$243,845:

Kauai - \$201,280.00

Maui - \$45,265.00

As required by Section 291C-111(c), the DOT disbursed the following amounts to the counties that issued the citations:

Kauai - \$100,640.00

Maui - \$21,282.50

**Enforcement**

During fiscal year 2023 (July 1, 2022 – June 30, 2023), the county police departments issued the following number of citations for Section 291C-111.5 HRS violations:

Hawaii Police Department – 2 citations

Honolulu Police Department - 1 citation

Kauai Police Department- 1,076 citations

Maui Police Department - 139 citations

## Signage Update

### Hawaii – District Office

The Hawaii District has installed “No Parking” signs at the following locations:  
Keaau Paho Road, Route 130 – 4 signs at MP 5.67 to 5.75

### Kauai – District Office

The Kauai District Office did not install any additional signs during this period.

### Maui – District Office

Since December 2022, Maui District maintenance personnel installed “No Parking” signs at the following locations:

- High Street, Route 30 – 1 sign at MP 0.2 (adjacent to crosswalk fronting Wailuku Elementary School)
- Honoapiilani Highway, Route 30 – 2 signs at MP 2.4 (to clear residential driveway sight distance)
- Hana Highway, Route 36 – 2 signs at MP 4.3 (vicinity of Stable Road, to discourage homeless camps)
- Hana Highway, Route 36 – 2 signs at MP 10 (vicinity of Maliko Stream Bridge)

### Oahu – District Office

The Oahu District Office installed 28 “No Parking” signs during this period.
