## A BILL FOR AN ACT

RELATING TO THE WATER POLLUTION CONTROL SPECIAL FUND.

#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The State of Hawaii is responsible for the 2 management, protection, and restoration of both marine and 3 freshwaters within the State. As development, population, and 4 tourism continue to grow, protection of State surface water 5 quality is critical to ensuring that such growth is compatible 6 with environmental protection and public health. The vast 7 amount of surface waters within the State are not monitored 8 frequently enough to determine how best to manage, restore, and 9 protect those waters due to limited funding and resources. The 10 creation of a special fund would give the department of health 11 additional resources necessary to fund activities necessary to 12 monitor and manage State water quality.

13 The purpose of this Act is to establish the water pollution 14 control special fund for collection of permit, certification, 15 and variance fees to provide a supplemental source of funding 16 for activities for the purpose of water quality management as 17 implemented in permits, certifications, and variances.

**Report Title:** Fees; Water Pollution Control Special Fund

#### Description:

Establishes the Water Pollution Control Special Fund to collect fees formerly deposited to the State general fund to create a supplemental source of funding to implement and enforce water quality management as implemented in permits, certifications, and variances. Appropriates funds to be used by the Department of Health for the purposes of the Water Pollution Control Special Fund.

#### JUSTIFICATION SHEET

#### DEPARTMENT: HEALTH

TITLE: A BILL FOR AN ACT RELATING TO THE WATER POLLUTION CONTROL SPECIAL FUND.

PURPOSE: Establish the Water Pollution Control Special Fund for the collection of fees previously credited to the State general fund to provide a direct and supplemental source of funding for activities to implement and enforce permits, certifications, and variances.

MEANS: Amend section 342D-13, Hawaii Revised Statutes (HRS).

JUSTIFICATION: The State of Hawaii is responsible for managing, protecting, and restoring State waters. The State has approximately 303 miles of recreational shoreline, 3,326 miles of rivers and streams, and 37 square miles of bays and harbors - a total of 565 marine water bodies statewide, only 170 of which were assessed from 2019 to 2021 (30%). Of the 170 assessed water bodies, 157 (92%) do not fully attain water quality standards for one or more parameters.

> The establishment of, and funding from, the Water Pollution Control Special Fund is necessary for the Department of Health (Department) to more adequately carry out the State's responsibilities in managing, protecting, and restoring State waters. The establishment of this special fund would give the Department access to the approximately \$250,000 of permit, certification, and variance filing fees collected annually to meet these responsibilities.

Fees collected pursuant to section 342D-13, HRS, are imposed to cover the cost of issuing, implementing, and enforcing permits, certifications, and variances, but such fees are deposited to the general fund. Changing the account into which these fees are deposited and allowing it to be used by the Department for the stated purposes would allow the Department to fund more implementation and enforcement activities and generally be more responsive.

For example, the development and assessment of Total Maximum Daily Loads (TMDLs), which are water body-based planning and implementation tools, would benefit from additional resources. Water bodies that do not meet State water quality standards are required by federal law to have a TMDL established for it to improve water quality and bring it back to compliance. Timely development, implementation, and enforcement of a TMDL is in the State's best interest in terms of the economy, health and safety, the environment, and aquatic life.

At the current level of resources and funding, it takes approximately two to three years to develop a TMDL, depending on the complexity of the water body. Assuming funding and resources remain unchanged, it would potentially take decades to develop TMDLs for all impaired State surface water bodies, and even longer to properly evaluate the effects of the TMDL. With the use of this proposed special fund, TMDLS could be developed much faster.

Current federal and state funding is just enough to cover operating expenses for the 38 Clean Water Branch staff, including equipment and supplies. The amount of federal funding has been stagnant for the past few decades and is not expected to increase.

<u>Impact on the public:</u> Positive. Additional monitoring, increased development of TMDLs, enforcement, and implementation of permits, certifications, and variances all contribute

to improving water quality and protecting public health and the environment.

Impact on the department and other agencies: Positive. In addition to the benefits for the public, this fund provides a controllable source of funding to the Department for the additional protective activities to protect and improve water quality.

GENERAL FUND: All moneys collected from fees on or after July 1, 2023, approximately \$250,000 per year, shall be deposited to the credit of the Water Pollution Control Special Fund instead of credited to the general fund.
