RELATING TO RENEWAL OF DRIVER'S LICENSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 286-107, Hawaii Revised Statutes, is amended as follows: 2 3 1. By amending subsection (c) to read: 4 "(c) Any person who holds a category (1), (2), or (3) license issued under this part [who is unable to appear in 5 6 person before the examiner of drivers to apply for a renewal of 7 the driver's license, may[, apply for a renewal of the driver's license online, by using any electronic or digital 8 means provided by the examiner of drivers, or by mail, if the 9 10 person is not disqualified from renewing the license under 11 subsection (a) except as provided under subsection (h) [, apply for a renewal by mail]. The applicant's request to have the 12 13 license renewed by mail must be received by the examiner of 14 drivers within ninety days after the expiration of the license 15 or it shall be treated as an application for reactivation of an 16 expired license under section 286-107.5. The examiner of

drivers shall, upon receipt of the request, furnish the

1	applicant with all necessary forms and instructions. An
2	application for renewal by electronic or digital means or mail
3	made pursuant to this subsection shall be accompanied by a
4	statement from a licensed physician, physician assistant, or
5	advanced practice registered nurse certifying that the applicant
6	was examined by the licensed physician, physician assistant, or
7	advanced practice registered nurse $[rac{not}{n}]$ $rac{no}{n}$ more than six months
8	[prior to] before the expiration date of the applicant's license
9	and that the applicant was found by the examination to have met
10	the physical requirements established by the state director of
11	transportation for the renewal of licenses. The application for
12	renewal by electronic or digital means or mail shall also be
13	accompanied by:
14	(1) A notarized statement of the applicant certifying that

3	2. By amending subsection (f) to read:
4	"(f) No driver's license shall be renewable by electronic
5	or digital means or mail:
6	(1) For more than two consecutive renewals, regardless of

8	286-106, on the eighth[τ] or fourth[τ or second]
9	birthday after issuance; or
10	(2) Sixteen years have lapsed since the applicant had
11	appeared in person;
12	provided that this subsection shall not apply to a resident
13	military person or that person's immediate family if the
14	resident military person resides outside the State on official
15	military orders."
16	SECTION 2. Statutory material to be repealed is bracketed
17	and stricken. New statutory material is underscored.
18	SECTION 3. This Act shall take effect on July 1, 2025.
