# A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE  
TWENTY-FOURTH REPRESENTATIVE DISTRICT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The director of finance is authorized to issue  
2 general obligation bonds in the sum of \$37,850,000 or so much  
3 thereof as may be necessary and the same sum or so much thereof  
4 as may be necessary is appropriated for fiscal year 2023-2024  
5 for the purpose of capital improvement projects for the twenty-  
6 fourth representative district, as follows:

7       1. Ala Wai elementary school  
8           Construction and equipment and  
9           appurtenances to re-cable all  
10          horizontal cabling from the electrical  
11          room to the IDF/MDF with CAT6 cable,  
12          new UPS's for each IDF/MDF, bells and  
13          paging speakers, and cost for new  
14          phones.

15          Construction	\$350,000
16          Equipment	\$350,000









1           The sum appropriated for this capital improvement project  
2 shall be expended by the department of land and natural  
3 resources.

4 8.   Ala Wai small boat harbor

5           Design and construction for upgrades  
6           and replacement of existing electrical  
7           lines, conduits, lighting, circuit  
8           breakers, and related work.

9	Design	\$300,000
10	Construction	\$5,000,000
11	Total funding	\$5,300,000

12           The sum appropriated for this capital improvement project  
13 shall be expended by the department of land and natural  
14 resources.

15 9.   Kawehehe beach

16           Plans, design, and construction for a  
17           beach restoration pilot project.

18	Plans	\$100,000
19	Design	\$100,000
20	Construction	\$450,000
21	Total funding	\$650,000



# H.B. NO. 1123

1           The sum appropriated for this capital improvement project  
2 shall be expended by the department of land and natural  
3 resources.

4           SECTION 2. The appropriation made for the capital  
5 improvement projects authorized by this Act shall not lapse at  
6 the end of the fiscal year for which the appropriation is made;  
7 provided that all moneys from the appropriation unencumbered as  
8 of June 30, 2026, shall lapse as of that date.

9           SECTION 3. This Act shall take effect on July 1, 2023.
