# H.B. NO. (293)

#### A BILL FOR AN ACT

RELATING TO FARM ANIMALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to improve the
2	regulation of egg production and sales to protect the health and
3	welfare of consumers, promote food safety, advance animal
4	welfare, and protect against the negative fiscal effects on the
5	State associated with the lack of effective regulation of egg
6	production and sales.
7	SECTION 2. The Hawaii Revised Statutes is amended by
8	adding a new chapter to be appropriately designated and to read
9	as follows:
10	"CHAPTER
11	CONFINEMENT STANDARDS FOR EGG-LAYING HENS
12	<b>§ -1 Definitions.</b> As used in this chapter:
13	"Business owner or operator" means any person who owns or
14	controls the operations of a business.
15	"Cage-free housing system" means an indoor or outdoor
16	controlled environment for egg-laying hens within which hens are
17	free to roam unrestricted; are provided enrichments that allow



1 hens to exhibit natural behaviors, including scratch areas, 2 perches, nest boxes, and dust bathing areas; and within which 3 farm employees can provide care while standing within the hens' 4 usable floor space. "Cage-free housing system" includes: 5 (1)Multi-tiered aviaries; 6 (2) Partially-slatted systems; 7 (3) Single-level all-litter floor systems; and 8 (4) Any other system that complies with the requirements 9 of this chapter. 10 "Egg products" means eggs of an egg-laying hen broken from 11 the shells and intended for human food, whether in liquid, 12 solid, dried, or frozen form; whether raw or cooked; and with 13 the yolks and whites in their natural proportions, or with the 14 yolks and whites separated, mixed, or mixed and strained. "Egg 15 products" does not include combination food products, including 16 pancake mixes, cake mixes, cookies, pizzas, cookie dough, ice 17 cream, or similar food products that consist of more than egg 18 products, sugar, salt, water, seasoning, coloring, flavoring, 19 preservatives, stabilizers, and similar food additives.

1 "Egg-laying hen" means a female domesticated chicken, 2 turkey, duck, goose, or guinea fowl kept for the purpose of 3 commercial egg production. 4 "Enclosure" means a structure used to confine an egg-laying 5 hen or hens. 6 "Farm" means the land, building, support facilities, and other equipment that are wholly or partially used for the 7 8 commercial production of animals or animal products used for 9 food. "Farm" does not include live animal markets or official 10 plants at which mandatory inspection is maintained under the 11 federal Egg Products Inspection Act (21 U.S.C. section 1031, et 12 seq.). 13 "Farm owner or operator" means any person who owns or 14 controls the operations of a farm. 15 "Multi-tiered aviary" means a cage-free housing system in 16 which hens have unfettered access to multiple elevated platforms 17 that provide hens with usable floor space on top of and 18 underneath the platforms. 19 "Partially-slatted system" means a cage-free housing system 20 in which hens have unfettered access to elevated flat platforms

under which manure drops through the flooring to a pit or litter
 removal belt below the platform.

3 "Person" means any individual, firm, partnership, joint
4 venture, association, limited liability company, corporation,
5 estate, trust, receiver, or syndicate.

6 "Sale" or "sells" means a commercial sale by a business
7 that sells any item covered by this chapter but does not include
8 any sale undertaken at an official plant at which mandatory
9 inspection is maintained under the federal Egg Products
10 Inspection Act (21 U.S.C. section 1031, et seq.).

"Shell egg" means a whole egg of an egg-laying hen in itsshell form that is intended for use as human food.

13 "Single-level all-litter floor system" means a cage-free
14 housing system bedded with litter, in which hens have limited or
15 no access to elevated flat platforms.

16 "Usable floor space" means the total square footage of 17 floor space provided to each egg-laying hen, as calculated by 18 dividing the total square footage of floor space provided to the 19 egg-laying hens in an enclosure by the number of egg-laying hens 20 in that enclosure. "Usable floor space" includes both ground

1	space and elevated level or nearly level flat platforms upon
2	which hens can roost but does not include perches or ramps.
3	<b>§ -2 Prohibitions.</b> Notwithstanding any other provision
4	of law to the contrary, beginning no later than January 1, 2025,
5	it shall be unlawful for:
6	(1) A farm owner or operator within the State to knowingly
7	confine an egg-laying hen in an enclosure that:
8	(A) Is not a cage-free housing system; or
9	(B) Has less than the amount of usable floor space
10	per egg-laying hen required by the 2017 edition
11	of the United Egg Producers' Animal Husbandry
12	Guidelines for U.S. Egg-Laying Flocks:
13	Guidelines for Cage-Free Housing; and
14	(2) A business owner or operator to knowingly engage in
15	the sale in the State of any shell egg or egg product
16	that the business owner or operator knows or should
17	know was produced by an egg-laying hen that was
18	confined in a manner that conflicts with the standards
19	for enclosures described in paragraph (1).
20	<b>§ -3 Exceptions.</b> Section -2 shall not apply during:
21	(1) Medical research;

-5 Certification. Beginning no later than January 1, 1 Ş. 2 2025, no business owner or operator shall engage in the sale of 3 shell eggs or egg products within the State without a 4 certificate from the department of agriculture certifying that the shell eggs or egg products were produced in compliance with 5 6 this chapter or are exempt under this chapter. The department of agriculture shall certify that shell eggs and egg products 7 8 are accompanied by documentation from a government or private 9 third-party inspection and continuous process verification 10 service that the department deems acceptable, which establishes 11 that the shell eggs or egg products were produced in compliance 12 with this chapter.

13 § -6 Penalties. (a) Any person who violates any
14 provision of this chapter shall be subject to a fine of no less
15 than \$500 and no more than \$1,000 per violation.

(b) In addition to the penalties listed in subsection (a),
a violation of section -2(2) shall be considered an unfair
method of competition and unfair or deceptive trade practice
under chapter 481A, upon which any person may bring an action.
§ -7 Defense. It shall be a defense to any action to
enforce this chapter that a business owner or operator relied in



1 good faith upon a written certification by the supplier that the 2 shell egg or egg products were not derived from an egg-laying 3 hen that was confined in a manner that conflicts with the 4 standards for enclosures described in section -2(1).

§ -8 Rules. The department of agriculture shall adopt
rules pursuant to chapter 91 necessary for the purposes of this
chapter; provided that section -2 shall apply to egg-laying
hens and shell eggs and egg products sold in the State beginning
January 1, 2025, whether or not the department has finalized
rules for the purposes of this chapter.

11 § -9 Construction. The provisions of this chapter shall
12 be in addition to, and not in lieu of, any other law protecting
13 animal welfare. This chapter shall not be construed to limit
14 any other state laws or rules protecting the welfare of animals
15 or prevent the counties from adopting and enforcing ordinances,
16 laws, and rules that are more restrictive than this chapter."
17 SECTION 3. If any provision of this Act, or the

18 application thereof to any person or circumstance, is held 19 invalid, the invalidity does not affect other provisions or 20 applications of the Act that can be given effect without the

#### Report Title:

Egg-laying Hens; Confinement Standards; Agriculture; Certification

#### Description:

Beginning no later than 1/1/2025: requires farm owners or operators to confine egg-laying hens in accordance with certain standards, with exceptions; prohibits a business owner or operator from selling shell eggs or egg products that are produced by egg-laying hens that were confined in a manner that violates certain standards, with exceptions; and requires the department of agriculture to certify a business owner or operator who sells shell eggs or egg products within the State.
