A BILL FOR AN ACT

RELATING TO SENIOR CITIZENS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1 | SECTION 1. The Hawaii Revised Statutes is amended by |

| 14 | (c) The executive director may appoint staff as needed to |
| 15 | carry out the purposes of this section. Staff appointed |
| 16 | pursuant to this section shall be exempt from chapters 76 and 89 |
| 17 | but shall be members of the state employees' retirement system |

and shall be eligible to receive the benefits of any state
 employee benefit program generally applicable to officers and

4 (d) Department directors may assign additional employees
5 from existing positions within their respective department to

10 § -2 Kupuna benefits program; functions of the office.
11 (a) There is established the kupuna benefits program to be
12 administered by the office of senior citizen affairs. The
13 office shall work with participating businesses to provide
14 benefits and special privileges to eligible senior citizens
15 through the kupuna benefits program.

(b) A business who wishes to participate in the kupuna
benefits program shall register with the office of senior
citizen affairs. Eligible senior citizens wishing to
participate in the kupuna benefits program shall apply with the
office. The office shall establish a means for participating
