

A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR SCHOOLS IN THE THIRTY-EIGHTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The following sums, or so much thereof as shall
2	be sufficient to finance the projects listed in this Act, are
3	hereby appropriated out of the general revenues of the State of
4	Hawaii for fiscal year 2023-2024:
5	1. Kipapa elementary, Oahu
6	A. Construction of covered play court, land preparation,
7	construction of a stage, bathrooms and storage. These are
8	additional funds to approved 2021 appropriations to cover
9	increased costs.

12	B. Air conditioning the cafeteria.
