A BILL FOR AN ACT

RELATING TO THE WORKS OF ART SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 103-8.5, Hawaii Revised Statutes, is
amended as follows:

3 1. By amending subsection (a) to read:

4 "(a) There is created a works of art special fund, into which shall be transferred [one] 0.5 per cent of all state fund 5 6 appropriations for capital improvements designated for the construction cost element; provided that this transfer shall 7 8 apply only to capital improvement appropriations that are 9 designated for the construction [or renovation] of new state buildings[-], properties, or facilities. The [one] 0.5 per cent 10 11 transfer requirement shall not apply to appropriations from the 12 passenger facility charge special fund established by section 261-5.5 and the rental motor vehicle customer facility charge 13 14 special fund established under section 261-5.6."

15 2. By amending subsection (c) to read:

16 "(c) The [one] 0.5 per cent amount, which is included in 17 all capital improvement appropriations $[\tau]$ designated for the

1	construction of new state buildings, properties, or facilities,
2	shall be calculated at the time the appropriation bills are
3	signed into law. The moneys shall be transferred into the works
4	of art special fund upon availability of moneys from the
5	appropriations. Each agency receiving capital improvement
6	appropriations shall calculate the $[one] 0.5$ per cent amount and
7	transfer the moneys into the works of art special fund."
8	3. By amending subsections (e) and (f) to read:
9	"(e) The comptroller shall:
10	(1) Provide each agency receiving capital improvement
11	appropriations with information regarding items that
12	shall be included and excluded from the $[one] 0.5$ per
13	cent amount;
14	(2) Ensure that each agency calculates its $[one] 0.5$ per
15	cent amount correctly; and
16	(3) Ensure that each agency transfers the correct amount
17	to the works of art special fund in a timely manner.
18	(f) The comptroller and the executive director shall track
19	amounts due from each agency under the $[one]$ 0.5 per cent
20	requirement as provided in this section."
