# H.B. NO. **IS84**

#### A BILL FOR AN ACT

RELATING TO AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that agricultural crimes, 2 including agricultural theft and vandalism, are a persistent issue affecting Hawaii farmers and ranchers. According to a 3 4 2020 publication by the United States Department of Agriculture 5 and Hawaii Department of Agriculture, there were nearly nineteen thousand incidents of theft, vandalism, and trespassing on 6 Hawaii farms in 2019. These incidents cost Hawaii farms 7 approximately \$14,400,000, or ten per cent of the estimated 2018 8 9 Hawaii net farm income, in theft and vandalism losses and 10 security costs.

11 The legislature further finds that people often trespass
12 onto Hawaii's farms to illegally hunt. These trespassers, who
13 are often armed with weapons and accompanied by dogs, can be
14 particularly dangerous and destructive for farming operations.
15 Reports have emerged regarding destroyed crops, lost livestock,
16 illegal drug use, litter, and discarded animal carcasses on farm
17 property.



1 The legislature also finds that despite the prevalence and 2 cost of agricultural crimes, many incidents go unreported and 3 few result in convictions. Of the nearly nineteen thousand 4 incidents in 2019, only nine hundred seventy incidents were 5 reported to law enforcement, which resulted in seventy-nine 6 arrests and sixty-seven convictions.

7 Recognizing the challenges that Hawaii farmers face with 8 regard to agricultural crime, the legislature passed Act 217, 9 Session Laws of Hawaii 2019, which required the department of 10 agriculture to establish a two-year agricultural theft and 11 vandalism pilot project to examine the effectiveness of 12 prosecuting agricultural and vandalism cases in the counties of 13 Hawaii and Maui. The legislature believes that it is time to 14 replicate this pilot project in the city and county of Honolulu 15 and county of Kauai, which suffered the highest and third highest rates of theft or vandalism of all farms in the State, 16 17 respectively.

18 Accordingly, the purpose of this Act is to establish a 19 two-year agricultural crime pilot project to examine the 20 effectiveness of prosecuting agricultural crime cases in the 21 city and county of Honolulu and county of Kauai, including

10	(c) The d	epartment of agriculture shall submit reports to
11	the legislature	of its findings and recommendations, including
12	any proposed le	gislation, no later than twenty days prior to the
13	convening of th	e regular sessions of 2025 and 2026.
14	SECTION 3.	There is appropriated out of the general
15	revenues of the	State of Hawaii the sum of \$200,000 or so much
16	thereof as may i	be necessary for fiscal year 2024-2025 for the
17	establishment a	nd implementation of a two-year agricultural
18	crime pilot pro	ject pursuant to this Act.
19	The sum ap	propriated shall be expended by the department of
20	agriculture for	the purposes of this Act.

1	SECTION 4. In accordance with section 9 of article VII of				
2	the Hawaii State Constitution and sections 37-91 and 37-93,				
3	Hawaii Revised Statutes, the legislature has determined that the				
4	appropriations contained in H.B. No. , will cause the state				
5	general fund expenditure ceiling for fiscal year 2024-2025 to be				
6	exceeded by \$ or per cent. In addition, the				
7	appropriation contained in this Act will cause the general fund				
8	expenditure ceiling for fiscal year 2024-2025 to be further				
9	exceeded by \$200,000 or per cent. The combined total				
10	amount of general fund appropriations contained in only these				
11	two Acts will cause the state general fund expenditure ceiling
