A BILL FOR AN ACT

RELATING TO LAW ENFORCEMENT OFFICERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that law enforcement 1 2 officers are authorized to use physical force to enforce laws and should be held to the highest standards to ensure that this 3 4 authority is not abused. Appropriate disciplinary actions should be taken against law enforcement officers who commit acts 5 6 of misconduct. The legislature believes that states must take 7 the initiative to address officer discipline, as federal action 8 on this issue has been lacking.

9 The legislature also finds that otherwise-qualified law
10 enforcement officers should not be denied the opportunity to
11 serve based solely on low-level drug-related offenses.

12 The purpose of this Act is to:

13 (1) Require law enforcement agencies and the law
14 enforcement standards board to consult the National
15 Decertification Index and ensure the reporting of
16 officer misconduct to the Index;

Requires reporting of certain domestic violence records to the National Decertification Index, notwithstanding any contrary law or court order. Provides that a law enforcement officer's conviction for promoting a detrimental drug in the third degree under section 712-1249, HRS, or any similar drug-related offense shall not serve as the sole reason to deny certification or employment to the officer.
