4	[(c)] <u>(e)</u> As used in this section[, "cesspool"]:
5	"Cesspool" means an individual wastewater system consisting
6	of an excavation in the ground whose depth is greater than its
7	widest surface dimension, that receives untreated wastewater,
8	and retains or is designed to retain the organic matter and
9	solids discharged into it, but permits the liquid to seep
10	through its bottom or sides to gain access to the underground
11	geographic formation.
12	"Transient accommodations" has the same meaning as in
13	section 237D-1."
14	SECTION 2. Statutory material to be repealed is bracketed
15	and stricken. New statutory material is underscored.
16	SECTION 3. This Act shall take effect on July 1, 3000.
