
A BILL FOR AN ACT

RELATING TO THE JUDICIARY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 **PART I. GENERAL PROVISIONS**

2 SECTION 1. This Act shall be known and may be cited as the
3 Judiciary Supplemental Appropriations Act of 2024.

4 SECTION 2. Act 70, Session Laws of Hawaii 2023, is amended
5 by amending part II to read as follows:

6 **"PART II. PROGRAM APPROPRIATIONS**

7 SECTION 3. The following sums, or so much thereof as may
8 be sufficient to accomplish the purposes and programs designated
9 herein, are appropriated or authorized from the sources of
10 funding specified to the judiciary for the fiscal biennium
11 beginning July 1, 2023, and ending June 30, 2025. The total
12 expenditures and the number of permanent and temporary positions
13 established in each fiscal year of the fiscal biennium shall not
14 exceed the sums and the position ceilings indicated for each
15 year, except as provided in this Act.

2 by amending section 7 to read as follows:

3 "SECTION 7. Provided that of the general fund
4 appropriation for administration (JUD601), the sum of \$333,333
5 or so much thereof as may be necessary for fiscal year 2023-2024
6 shall be expended for actuaries to determine cost-of-living
7 adjustments for [~~services on a fee basis costs~~] purchase of
8 service providers that account for [~~increase~~] increases in
9 inflation."

10 SECTION 4. Act 70, Session Laws of Hawaii 2023, is amended
11 by amending part IV to read as follows:

12 "PART IV. CAPITAL IMPROVEMENT PROJECTS

13 SECTION 8. The sum of [~~\$20,955,000~~] \$37,955,000
14 appropriated or authorized in part II of this Act for capital
15 improvement projects shall be expended by the judiciary for the
16 projects listed below; provided that several related or similar
17 projects may be combined into a single project, if a combination
18 is advantageous or convenient for implementation; provided
19 further that the total cost of the projects thus combined shall
20 not exceed the total of the sums specified for the projects
21 separately. The amount after each cost element and the total



1 funding for each project listed in this part are in thousands of
2 dollars.

1 SECTION 5. Act 70, Session Laws of Hawaii 2023, is amended
2 by amending part V to read as follows:

3 "PART V. ISSUANCE OF BONDS

4 SECTION 9. General obligation bonds may be issued, as
5 provided by law, to yield the amount that may be necessary to
6 finance projects authorized in part II and listed in part IV of
7 this Act; provided that the sum total of the general obligation
8 bonds so issued shall not exceed [~~\$17,955,000.~~] \$31,955,000."

9 SECTION 6. Act 38, Session Laws of Hawaii 2019, as amended
10 by Acts 5 and 9, Session Laws of Hawaii 2020, is amended by
11 amending section 7.1 to read as follows:

12 "SECTION 7.1. [~~(a) Beginning on the effective date of~~
13 ~~this Act the judiciary shall submit a weekly report to the~~
14 ~~legislature that includes the following information for all~~
15 ~~inmates released pursuant to supreme court orders entered in~~
16 ~~SCPW 20-0000200 and SCPW 20-0000213.~~

- 17 ~~(1) The inmate's name;~~
- 18 ~~(2) The inmate's release date;~~
- 19 ~~(3) The correctional center or facility where the inmate~~
20 ~~was released from;~~



- 1 ~~(4) The inmate's criminal status before release, for~~

18 SECTION 7. In accordance with section 9 of article VII, of
19 the Constitution of the State of Hawaii and sections 37-91 and
20 37-93, Hawaii Revised Statutes, the legislature has determined
21 that the appropriations contained in this Act will cause the



1 state general fund expenditure ceiling for fiscal year 2024-2025
2 to be exceeded by \$, or per cent. The
3 reasons for exceeding the general fund expenditure ceiling are
4 that the appropriations made in this Act are necessary to serve
5 the public interest and to meet the needs provided for by this
6 Act.

7 SECTION 8. If any portion of this Act or its application
8 to any person or circumstances is held to be invalid for any
9 reason, the remainder of the Act and any provision thereof shall
10 not be affected. If any portion of a specific appropriation is
11 held to be invalid for any reason, the remaining portion shall
12 be independent of the invalid portion and shall be expended to
13 fulfill the objective and intent of the appropriation to the
14 extent possible.

15 SECTION 9. If any manifest clerical, typographical, or
16 other mechanical error is found in this Act, the chief justice
17 may correct the error. All changes made pursuant to this
18 section shall be reported to the legislature at its next regular
19 session.

20 SECTION 10. Statutory material to be repealed is bracketed
21 and stricken. New statutory material is underscored.



1 SECTION 11. This Act shall take effect on July 1, 2024.
