A BILL FOR AN ACT

RELATING TO TOBACCO PRODUCTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Act 62, Session Laws of Hawaii 2023 (Act 62), provides, among other things, 2 additional layers of protection against the rapid growth of the 3 use of electronic smoking devices, including financial 4 disincentives to purchase these products, for consumers in the 5 State, especially for youth and young adults. However, Act 62 6 7 also establishes the offense of unlawful shipment of tobacco products, including large cigars, which has created unintended 8 9 consequences for many consumers in the State.

10 The purpose of this Act is to repeal certain provisions 11 established under Act 62 to allow for the shipment of tobacco 12 products to consumers in the State.

13 SECTION 2. Section 245-16.5, Hawaii Revised Statutes, is14 repealed.

9	(e) For purposes of this section:
10	(1) A person or entity is a licensee if the person's or

13	-(2) "Value" means the retail fair market value at the time
14	of the offense."]
15	SECTION 3. Statutory material to be repealed is bracketed
16	and stricken.
17	SECTION 4. This Act shall take effect upon its approval.
