#### A BILL FOR AN ACT

RELATING TO HARASSMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 711, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" <u>§711-</u> Harassment by use of location tracker. (1) A
5	person commits the offense of harassment by use of location
6	tracker if that person uses a location tracker with the intent
7	to harass, stalk, or perpetuate a crime against another person
8	without their knowledge.
9	(2) For purposes of this section, "location tracker" means
10	an electronic or mechanical device that allows a person to
11	remotely determine or track the position or movement of another
12	person or an object. The term includes the following:
13	(a) A device that stores geographic data for subsequent
14	access or analysis;
15	(b) A device that allows real-time monitoring or movement;
16	(c) An unmanned aerial vehicle as defined in section
17	188-23.5; or



1	(d)	A cellular telephone or other wireless or cellular
2		communications device, or an electronic device that
3		communicates with a cellular telephone or other
4		wireless or cellular communications device, including
5		by means of an application installed on or accessed
6		through a cellular telephone or other wireless or
7		cellular communications device.
8	(3)	Harassment by use of location tracker is a
9	misdemean	or."
10	SECT	ION 2. Section 711-1111, Hawaii Revised Statutes, is
11	amended b	y amending subsection (1) to read as follows:
12	"(1)	A person commits the offense of violation of privacy
13	in the se	cond degree if, except in the execution of a public
14	duty or a	s authorized by law, the person intentionally:
15	(a)	Trespasses on property for the purpose of subjecting
16		anyone to eavesdropping or other surveillance in a
17		private place;
18	(b)	Peers or peeps into a window or other opening of a
19		dwelling or other structure adapted for sojourn or
20		overnight accommodations for the purpose of spying on
21		the occupant [ <del>thereof</del> ] or invading the privacy of

another person with a lewd or unlawful purpose, under 1 circumstances in which a reasonable person in the 2 dwelling or other structure would not expect to be 3 observed; 4 5 Trespasses on property for the sexual gratification of (C) 6 the actor; Installs or uses, or both, in any private place, 7 (d) without consent of the person or persons entitled to 8 privacy therein, any means or device for observing, 9 recording, amplifying, or broadcasting sounds or 10 11 events in that place other than another person in a stage of undress or sexual activity; provided that 12 this paragraph shall not prohibit a person from making 13 a video or audio recording or taking a photograph of a 14 law enforcement officer while the officer is in the 15 performance of the officer's duties in a public place 16 or under circumstances in which the officer has no 17 reasonable expectation of privacy and the person is 18 not interfering with the officer's ability to maintain 19 safety and control, secure crime scenes and accident 20 sites, protect the integrity and confidentiality of 21

18		prohibited in section 711"
19	SECT	ION 3. This Act does not affect rights and duties that
20	matured,	penalties that were incurred, and proceedings that were
21	begun bef	ore its effective date.
