A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the people of Hawaii 1 2 have significant concerns about the effects of over-tourism, 3 including on the environment. The legislature further finds 4 that there is a proliferation of rental kayaks and stand-up 5 paddleboards statewide. The legislature also finds that it is 6 beneficial for the residents and natural resources of the State 7 to regulate commercial rentals where the park itself is the 8 location of the watercraft activity. The legislature 9 additionally finds that Wailua river state park on Kauai, 10 Kealakekua bay state historic park on Hawaii island, and Ahupuaa 11 O Kahana state park on Oahu are examples of such locations.

12 Therefore, the purpose of this Act is to require for five 13 years the registration and numbering of rental watercraft before 14 they are provided or offered to the public for transiting the 15 navigable waters of a state park.
