A BILL FOR AN ACT

RELATING TO REGENERATIVE TOURISM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the adverse effects of traditional tourism on Hawaii's ecological and cultural landscape have contributed to environmental degradation and cultural dilution. There is an urgent need to shift towards a tourism model that actively contributes to environmental restoration, cultural integrity, and economic resilience within the local community.

8 The legislature further finds that regenerative tourism can 9 prevent and mitigate environmental disasters, including limiting 10 coastal erosion, reducing reef dieback, and helping to prevent 11 wildfires by promoting sustainable environmental practices.

12 The legislature also finds that addressing economic 13 challenges in Hawaii, particularly the high cost of living and 14 operation, emphasizes the need for substantial startup support.

15 The legislature commits to transforming the State's tourism 16 sector into a regenerative, sustainable model that benefits the
