A BILL FOR AN ACT

RELATING TO CEMETERIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Sunset Memorial Park 2 in Pearl City, Oahu, has been neglected for years and has been 3 the subject of numerous complaints by individuals who have 4 family members buried there. The cemetery has been described as 5 having a damaged mausoleum, sinking graves, and markers that are 6 hidden under overgrown grass and bushes. The cemetery was owned 7 and operated by a corporation. That corporation, Hawaiian 8 Cemetery Association Ltd. dba Sunset Memorial Park, 9 involuntarily dissolved in 2010. Garden Crypts Inc. owns a 10 small portion of the property that is the site of the mausoleum. 11 That entity was involuntarily dissolved in 2006.

Act 193, Session Laws of Hawaii 2018 (Act 193), was enacted to limit liability for the overwhelming number of volunteers maintaining or repairing the cemetery grounds at Sunset Memorial Park. Act 193 further required the department of commerce and consumer affairs, in consultation with the department of accounting and general services, to develop short-term and long-



term strategies for the upkeep, repair, and maintenance of
 Sunset Memorial Park. As a result of Act 193, the department of
 commerce and consumer affairs worked with a surveyor to map the
 cemetery and create a website and database to help identify
 graves at Sunset Memorial Park.

6 The department of commerce and consumer affairs launched 7 the website portal on February 18, 2022, to provide access to 8 grave marker information at Sunset Memorial Park. This portal 9 also allowed members of the public who have family members 10 buried at the cemetery to share information regarding their plot 11 as well as information on purchased plots that are vacant or 12 unmarked. The department of commerce and consumer affairs did 13 not receive much information regarding plots at the cemetery. 14 Due to the lack of an owner for the cemetery, there is no 15 security for Sunset Memorial Park, and the Park is often the 16 target of vandalism and desecration, with thieves displacing 17 ashes from copper urns to sell the urns, headstones taken off 18 grave sites, and homeless encampments setting fire to the area. 19 The effects of cemetery vandalism are not limited to property 20 damage but can also extend to emotional trauma to the relatives

and friends of the decedent whose grave has been damaged or
 desecrated.

3 The purpose of this Act is to permit the director of
4 commerce and consumer affairs to appoint a limited owner of a
5 cemetery for which no owner can be found and authorize the
6 limited owner to:

- 7 (1) File complaints, including but not limited to trespass
 8 complaints with the appropriate law enforcement
 9 authorities against persons engaged in wrongful acts
 10 at the cemetery; and
- 11 (2) Engage in certain security and perpetual care12 activities for the cemetery.

13 SECTION 2. Chapter 662D, Hawaii Revised Statutes, is
14 amended by adding a new section to be appropriately designated
15 and to read as follows:

16 "<u>\$662D-</u> Limited ownership of cemetery grounds. (a)
17 The director of commerce and consumer affairs may, in accordance
18 with subsection (b), appoint an organization as the limited
19 owner of a cemetery for the purpose of bringing criminal, civil,
20 or administrative complaints, including trespass or other

1 (d) Any organization designated as a limited owner shall 2 be entitled to the same limited liability protections as 3 volunteers under section 662D-5. 4 (e) Any organization designated as a limited owner shall 5 submit annual reports to the department of commerce and consumer 6 affairs on the status and progress of any new and existing 7 initiatives undertaken to improve the cemetery. 8 (f) The director of commerce and consumer affairs may, in 9 the director's sole discretion, terminate the limited ownership 10 appointment at any time. 11 (g) Appointment as a limited owner of a cemetery property 12 under this section shall vest no property rights in or 13 entitlements to the land or property. The limited privileges 14 granted to a limited owner under this section shall not be 15 construed as vested rights and may be revoked at any time at the 16 sole discretion of the director of commerce and consumer 17 affairs. No action, including an action seeking damages, or 18 appeal under chapter 91 may be brought by any person against the 19 director or department of commerce and consumer affairs or 20 against the State relating to an organization's appointment, 21 non-appointment, or termination of a designation as a limited
