## A BILL FOR AN ACT

RELATING TO VETERANS RIGHTS AND BENEFITS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1  | SECTION 1. The purpose of this Act is to establish               |

| 3  | advising or assisting another person with veterans benefits.     |
| 4  | SECTION 2. Chapter 363, Hawaii Revised Statutes, is              |
| 5  | amended by adding a new part to be appropriately designated and  |

| 7  | "PART . VETERANS BENEFITS  |
| 8  | <b>§363- Prohibitions.</b> (a) No person shall receive           |
| 9  | compensation for advising or assisting any individual with       |
| 10 | regard to any veterans benefits matter, except as permitted      |
| 11 | under federal law.   |
| 12 | (b) No person shall receive compensation for referring any       |
| 13 | individual to another person for the purpose of receiving advice |
| 14 | or assistance with regard to any veterans benefits matter.       |
| 15 | (c) Before rendering any services, a person seeking to           |
| 16 | receive compensation for advising or assisting any individual    |

17 with any veterans benefits matter, shall memorialize in a





written agreement all terms regarding the individual's payment
 of fees for services rendered that adheres to all criteria
 specified within title 38 Code of Federal Regulations section
 14.636 and shall be signed by both parties.

5 (d) No person shall receive any compensation for any
6 services rendered before the date upon which a notice of
7 disagreement is filed with the Department of Veterans Affairs
8 with respect to the individual's case.

9 (e) No person shall guarantee, either directly or by
10 implication, that any individual is certain to receive specific
11 veterans benefits or that any individual is certain to receive a
12 specific level, percentage, or amount of veterans benefits.

(f) No person shall receive excessive or unreasonable fees as compensation for advising or assisting any individual with any veterans benefits matter. The factors articulated within title 38 Code of Federal Regulations section 14.636 shall govern determinations of whether a fee is excessive or unreasonable.

18 (g) Notwithstanding the foregoing, nothing in this section
19 shall be construed as prohibiting a division of fees between
20 attorneys which is otherwise proper under the Hawaii rules of
21 professional conduct.

The individual shall verbally 18 acknowledge understanding of the oral disclosure and shall sign 19 the document in which the written disclosure appears to indicate 20 understanding of these provisions. The person offering services 21 shall retain a copy of the written disclosure while providing

veterans benefits services for compensation to the individual
 and for at least one year after the date on which the services
 terminate.

4 §363- Advertising. (a) No person shall advertise
5 for-compensation services in veterans benefits matters unless
6 the advertisement includes the following disclosure:

A violation of the provisions of this §363-5 part shall be an unfair or deceptive act or practice under 6 chapter 481A and a violation of section 480-2." 7 SECTION 3. Chapter 363, Hawaii Revised Statutes, is 8 amended by designating sections 363-1 to 363-13 as part I, 9 entitled "General Provisions". 10 SECTION 4. Section 363-1, Hawaii Revised Statutes, is 11 amended by adding three new definitions to be appropriately 12 inserted and to read as follows: 13 ""Compensation" means payment of any money, thing of value, 14 or financial benefit. 15 "Person" means an individual, corporation, business trust, 16 estate, trust, partnership, limited liability company, 17 association, joint venture, public corporation, government or 18 governmental subdivision, agency, or instrumentality, or any 19 other legal or commercial entity. 20 "Veterans benefits matter" means the preparation, 21 presentation, or prosecution of any claim affecting any person
