A BILL FOR AN ACT

RELATING TO LAW ENFORCEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that, according to the 2 Task Force on Twenty-First Century Policing, increasing the 3 diversity of law enforcement agencies throughout the nation is 4 critical to developing trust between law enforcement agencies and the public. Additionally, the legislature notes that nearly 5 6 all modern national reports on law enforcement recommend the 7 increased employment of women and minorities in law enforcement. 8 The legislature recognizes that, when compared to male law 9 enforcement officers, female law enforcement officers generally 10 use less force, including excessive force; are named in fewer 11 lawsuits and complaints; are perceived by the public as being 12 more honest and compassionate; achieve better outcomes for crime 13 victims, especially victims of sexual assault; and make fewer 14 discretionary arrests.

Accordingly, the purpose of this Act is to establish as a goal of the State the increased representation of female law enforcement officers in the State by 2030 and require each law

1 enforcement agency to recruit law enforcement officers from 2 diverse backgrounds. 3 SECTION 2. Chapter 139, Hawaii Revised Statutes, is 4 amended by adding a new section to be appropriately designated 5 and to read as follows: 6 "\$139- Law enforcement officers; diversity. (a) The 7 State shall have a goal of each law enforcement agency increasing the employment of female law enforcement officers to 8 9 thirty per cent of all law enforcement officers employed by that 10 law enforcement agency by 2030; provided that each law 11 enforcement agency shall use the percentage of female law 12 enforcement officers employed by that law enforcement agency as 13 of January 1, 2023, as the benchmark for measuring the law 14 enforcement agency's progress toward achieving the goal set 15 forth herein. 16 (b) To effectuate the purposes of this section, each law enforcement agency shall recruit law enforcement officers from 17 diverse backgrounds, including schools of social work. 18 19 (c) As used in this section, "law enforcement agency" shall have the same meaning as in section 78-52." 20

21 SECTION 3. New statutory material is underscored.
