### A BILL FOR AN ACT

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to reclassify
 certain non-general funds of the department of accounting and
 general services, pursuant to the recommendations made by the
 auditor in auditor's report no. 23-17.

5 SECTION 2. Section 26-6, Hawaii Revised Statutes, is 6 amended by amending subsections (h) and (i) to read as follows: 7 The department of accounting and general services "(h) 8 shall preserve and protect Washington Place, including the 9 grounds and the historic residence situated on its premises at 10 Miller and Beretania Streets in Honolulu. The department shall 11 administer, manage, operate, and maintain Washington Place and 12 the [trust] special fund created under subsection (i).

(i) There is established a [trust] special fund in the
state treasury to be known as the Washington Place [trust]
special fund, into which shall be deposited:

16 (1) All rents and fees collected for the use of Washington
17 Place and from activities conducted on the premises;
