A BILL FOR AN ACT

RELATING TO TELECOMMUNICATIONS ACCESS FOR INDIVIDUALS WITH PRINT DISABILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the public utilities
commission provides critical services that ensure access to a
basic set of essential telecommunications services for
individuals who are blind or visually impaired.

5 In 2023, the governor signed Act 247, Session Laws of Hawaii 2023, into law, appropriating funds out of the public 6 7 utilities commission special fund for the public utilities 8 commission to provide free telecommunications access to certain 9 information for persons with a print disability. Act 247 10 provided \$150,000 for both fiscal year 2023-2024 and fiscal year 11 2024-2025. The legislature finds that Act 247 provides funding 12 for an important service that would be most appropriately funded 13 on an ongoing basis directly by telecommunication carriers whose 14 services are being supplemented rather than through the public 15 utilities commission special fund, which is largely funded 16 through a surcharge to electric ratepayers. The public

utilities commission's program will enhance the ho'opono services
currently administered by the department of human services.

3 The legislature further finds that section 269-41, Hawaii 4 Revised Statutes, established the universal service program, the 5 purpose of which, in relevant part, is to, assist customers with 6 disabilities, in obtaining and maintaining access to a basic set 7 of essential telecommunications services as determined by the 8 commission. Additionally, section 269-42(e), Hawaii Revised Statutes, requires the public utilities commission to require 9 10 all telecommunications carriers to contribute to the universal 11 service program. However, the universal service program is 12 currently not active and there are no funds in the universal 13 service fund. The public utilities commission also lacks clear 14 legislative authorization to develop a program for print 15 disability using the universal service fund. Further, the 16 public utilities commission does not have budget authorization 17 to expend funds for such purpose.

18 The purpose of this Act, therefore, is to clarify that, 19 under the universal service program, the public utilities 20 commission may provide free telephonic access and 21 telecommunication services for individuals with print 22 disabilities utilizing the universal service fund and may

JUSTIFICATION SHEET

DEPARTMENT: Commerce and Consumer Affairs

TITLE: A BILL FOR AN ACT RELATING TO TELECOMMUNICATIONS ACCESS FOR INDIVIDUALS WITH PRINT DISABILITIES.

PURPOSE: To clarify that, under the Universal Service Program, the Public Utilities Commission (Commission) may provide free telephonic access and telecommunication services for individuals with print disabilities utilizing the Universal Service Fund; and the Commission may determine the percentage of certain fees collected to be deposited into the Universal Service Fund to be used for the implementation of the program, and expend such funds.

- MEANS: Add a new section to part I of chapter 269, Hawaii Revised Statutes.
- JUSTIFICATION: Act 247, Session Laws of Hawaii 2023, appropriated funds from the Public Utilities Commission Special Fund for the Commission to provide free telecommunications access to certain information for persons with a print disability. This bill will ensure continuation of the ongoing services specified in Act 247 and uses the Universal Service Fund to implement the program.

<u>Impact on the public:</u> Secures telephonic access and telecommunication services for individuals with print disabilities, subject to available funding.

Impact on the department and other agencies: The Commission will be able to use the Universal Service Fund supported by telecommunications carriers' contributions rather than the Public Utilities Special Fund. The Commission's program will enhance the Ho'opono Services currently administered by the Department of Human Services. Page 2
