# A BILL FOR AN ACT

RELATING TO MANUFACTURED HEMP PRODUCTS.

#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that Act 263, Session 2 Laws of Hawaii 2023, amended regulations on hemp production and 3 manufactured hemp products. However, the definition of "manufactured hemp product" in section 328G-1, Hawaii Revised 4 5 Statutes, was inadvertently amended to be ambiguous and may be 6 read to limit the department of health's rulemaking authority to 7 regulate new types of hemp products as manufactured hemp 8 products. 9 The purpose of this Act is to clarify that the definition 10 of "manufactured hemp product" includes products intended to be
