### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 26-14.6, Hawaii Revised Statutes, is
2 amended as follows:

4 "(e) Effective July 1, 1990, the functions and authority
5 heretofore exercised by the department of health pursuant to
6 chapters 329 and 329C, with the exception of sections 329-2,
7 329-3, and 329-4[(3) to (8)], shall be transferred to the
8 department of public safety; and effective January 1, 2024,
9 those functions and authority shall be transferred to the
10 department of law enforcement."

11 2. By amending subsections (i) through (k) to read:
12 "(i) Effective January 1, 1993, the functions and
13 authority heretofore exercised by the director of health and
14 [the] department of health relating to uniformed security
15 employees and security contracts at various state hospitals
16 throughout the State shall be transferred to the department of
17 public safety; and effective January 1, 2024, those functions

and authority shall be transferred to the department of [law 1 enforcement.] health.
