A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that supporting local SECTION 1. 2 agriculture and strengthening local food systems is a matter of 3 statewide importance that can improve the resilience of Hawaii's economy, environment, culture, and public health. 4 The 5 legislature further finds that setting clear and ambitious 6 target goals for the purchase of locally grown food ensures that 7 the State plays its role in supporting local farmers and 8 guarantees that revenue derived from local produce remains in 9 the State and feeds local people. Act 175, Session Laws of 10 Hawaii 2021, established a programmatic goal for the department of education to provide a minimum of thirty per cent locally 11 12 sourced food in Hawaii public school meals by 2030. In 13 addition, the legislature also passed Act 176, Session Laws of 14 Hawaii 2021, which established five-year benchmarks ensuring a certain percentage of produce that is purchased by state 15 16 departments is locally grown.

1	The	legislature also finds that the existing goals set
2	different	standards for various state departments.
3	Specifica	lly, the programmatic goal for the department of
4	education	is to locally-source at least thirty per cent of food
5	served in	public schools by 2030, which is higher than other
6	state dep	artments. Furthermore, the department of education's
7	progress	towards its goal suggests that other state departments
8	should be	held to the same standard for the benefit of the
9	people of	Hawaii. The legislature believes that the goals to
10	provide l	ocally-sourced food should be consistent across all
11	pertinent	state departments to avoid any confusion between
12	departmen	ts.
13	Acco	rdingly, the purpose of this Act is to:
14	(1)	Increase the percentages of local agricultural
15		products that certain state departments and the
16		University of Hawaii system are required to purchase
17		by certain deadlines;
18	(2)	Expand the annual reporting requirements to include
19		total spending by certain market channels;
20	(3)	Require each relevant state department and the
21		University of Hawaii system to include a corrective

1 action plan in its respective report to the 2 legislature, should it not meet its benchmark; and 3 (4) Repeal the separate benchmark for the department of 4 education that requires thirty per cent of food served 5 in public schools to consist of locally sourced 6 products by 2030.

7 SECTION 2. Section 27-8, Hawaii Revised Statutes, is 8 amended by amending subsections (a) and (b) to read as follows: 9 "(a) The department of education, department of health, 10 department of public safety, department of defense, and 11 University of Hawaii system shall each ensure that a certain 12 percentage of the food purchased for public schools, youth 13 campuses, public hospitals, public prisons, and any purchases 14 made directly by the University of Hawaii for use in its academic programs, as applicable, is fresh local agricultural 15 products and local value-added, processed, agricultural, or food 16 17 products as follows:

18 (1) By January 1, 2025, fresh local agricultural products
19 and local value-added, processed, agricultural, or
20 food products shall constitute a minimum of [ten]
21 twenty-five per cent of the total food purchased

1 (5) By January 1, 2045, fresh local agricultural products 2 and local value-added, processed, agricultural, or 3 food products shall constitute a minimum of [fortytwo] forty-five per cent of the total food purchased 4 5 during each calendar year, as measured by the per cent of total food cost; and 6 7 (6) By January 1, 2050, fresh local agricultural products and local value-added, processed, agricultural, or 8 9 food products shall constitute a minimum of fifty per 10 cent of the total food purchased during each calendar 11 year, as measured by the per cent of total food cost. 12 (b) The department of education, department of health, 13 department of public safety, department of defense, and 14 University of Hawaii system shall each submit a report to the 15 legislature no later than twenty days prior to the convening of 16 each regular session on progress made toward meeting the 17 benchmarks described in subsection (a), including: 18 (1)The total cost of food purchased during the calendar 19 year preceding that regular session, or in the case of 20 the department of education, during the school year 21 preceding that regular session;

Food Contracts; Local Agricultural Products; Benchmarks; Reporting Requirements

Description:

Increases the percentages of local agricultural products that certain departments are required to purchase by certain deadlines. Expands annual reporting requirements to include the total spending by certain market channels. Requires each relevant state departments and the University of Hawaii system to include a corrective action plan in its respective report to the legislature, should it not meet its benchmark. Repeals the separate benchmark for the department of education that requires thirty per cent of food served in public schools to consist of locally sourced products by 2030.
