### A BILL FOR AN ACT

RELATING TO THE CERTIFICATION OF DOCUMENTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaii Revised Statutes is amended by

16	<b>§ -2 Fee.</b> (a) The office of the lieutenant governor
17	shall charge and collect a fee for each apostille or non-

apostille certification issued. Establishes the Apostilles and Certifications Special Fund. Requires the Office of the Lieutenant Governor to set a fee for the issuance of an apostille or a non-apostille certification by administrative rules. Appropriates funds into and out of the special fund.

#### JUSTIFICATION SHEET

DEPARTMENT: Lieutenant Governor.

- TITLE: A BILL FOR AN ACT RELATING TO THE CERTIFICATION OF DOCUMENTS.
- PURPOSE: To establish the Apostilles and Certifications Special Fund and require the Office of the Lieutenant Governor to set a fee for the issuance of an apostille or a non-apostille certification by administrative rules.
- MEANS: Adds a new chapter to Hawaii Revised Statutes and appropriates funds.
- JUSTIFICATION: The bill will allow the Office of the Lieutenant Governor to deposit fees generated by apostilles and certifications into the Apostilles and Certifications Special Fund to assist with modernization and operational expenses, including postage and supplies.

The Lieutenant Governor annually provides approximately 10,000 authentication services for all public and general documents that are used overseas, including powers of attorney, marriage certificates, birth certificates, divorce decrees, probated and un-probated wills, judgments, agreements, transcripts, and more.

The Office of the Lieutenant Governor is currently unable to accept credit card or web-based payment to authenticate documents and those seeking an apostille or certification must pay \$1 per authentication in cash or obtain a cashier's check that most banks charge \$15 to process. The Apostilles and Certifications Special Fund will ensure the Office of the Lieutenant Governor can execute its constitutional obligations and modernize its processes to best serve the public in a cost-effective and convenient manner. Deposits into the

Apostilles and Certifications Special Fund will defray increases in costs, including U.S. and international postage and supplies.

<u>Impact on the public:</u> Improved efficiency to certify documents will help to improve services provided to the public. The bill also ensures that the general public will not subsidize the cost of providing apostille and certification services to users.

Impact on the department and other agencies: The bill will provide the ability for the Office of the Lieutenant Governor to acquire funds to assist with modernization and operational expenses. Improved intake and operations could eventually lead to more efficient processes at other departments, such as the Department of Health, that route certification requests to the Office of the Lieutenant Governor.

GENERAL FUND: \$12,000.

In addition, all moneys collected from fees, current estimation of \$10,000 per year, on or after July 1, 2024, shall be deposited into the Apostilles and Certifications Special Fund instead of credited to the general fund.

OTHER FUNDS: The Apostilles and Certifications Special Fund.
