#### JUSTIFICATION SHEET

DEPARTMENT: Lieutenant Governor.

TITLE: A BILL FOR AN ACT RELATING TO TIME SHARE COMMISSIONERS OF DEEDS.

PURPOSE: To repeal the time share commissioners of deeds.

MEANS: Repeal chapter 503B, Hawaii Revised Statutes (HRS).

JUSTIFICATION: Chapter 503B, HRS, the law creating the time share commissioners of deeds, was enacted in 2013 to increase efficiency and convenience for foreign buyers to purchase Hawaii timeshare properties and boost Hawaii's tourism industry.

> Chapter 503B, HRS, was modeled after the state of Florida's Commissioners of Deeds program where commissioners are appointed to authenticate real estate transactions made in other jurisdictions, and authorizes the Lieutenant Governor to appoint commissioners in the United States, its territories, and possessions, and in any foreign country, and international waters, who may administer oaths and take acknowledgments and proofs of a deed, assignment of lease, mortgage, contract, power of attorney, or other instruments used in connection with time share interests, for use or recordation in Hawaii. There is no record of any Lieutenant Governor appointing any commissioner of deeds pursuant to chapter 503B, HRS.
