### A BILL FOR AN ACT

RELATING TO LAW ENFORCEMENT.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is an 2 increased frequency of illegal activity in the form of chop 3 shops on public lands. The legislature further finds that there 4 has been an increasing number of community complaints about 5 public lands being used as locations for dismantling of stolen 6 mopeds and bicycles. These chop shops, in addition to acting as 7 sites for illegal disassembly and redistribution of parts, also 8 litter the State's sidewalks, parks, streams, bridges, and other 9 open spaces with unusable debris left for disposal by state and 10 county agencies.

11 The purpose of this Act is to:

12 (1) Strengthen the county police departments'
13 investigation and enforcement abilities by making the
14 act of dismantling a bicycle or moped on public
15 property the trigger for police investigation and the
16 basis for a criminal offense; and

12	unlawful	assembly or disassembly of a bicycle or moped on public
13	property	if the person knowingly assembles or disassembles a
14	bicycle or moped on public property.	
15	(2)	It shall be an affirmative defense to prosecution
16	under thi	s section that the defendant:
17	<u>(a)</u>	Assembles or disassembles bicycles or mopeds under a
18		valid license or permit authorizing such activities on
19		the public property; or
20	<u>(b)</u>	Is repairing the bicycle or moped as a result of
21		malfunction or damage that occurred while the

2	and the defendant is the registered owner of or, with	
3	the consent of the registered owner, operated the	
4	bicycle or moped.	
5	(3) Any bicycle or moped in the person's possession at the	
6	time of violation of this section may be seized and ordered	
7	forfeited to the State, subject to the requirements of chapter	
8	<u>712A.</u>	
9	(4) Unlawful assembly or disassembly of a bicycle or moped	
10	on public property is a petty misdemeanor.	
11	(5) For purposes of this section:	
12	"Bicycle" has the same meaning as in section 249-1.	
13	"Moped" has the same meaning as in section 249-1.	
14	"Public property" means any public right-of-way, street,	
15	sidewalk, alley, parkway, public passageway, beach, park, or	
16	other public property owned or managed by the State or any of	
17	the counties."	
18	SECTION 3. This Act does not affect rights and duties that	
19	matured, penalties that were incurred, and proceedings that were	
20	begun before its effective date.	
21	SECTION 4. New statutory material is underscored.	



1 SECTION 5. This Act shall take effect on July 1, 2024.
