# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HUMAN RESOURCES DEVELOPMENT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature appreciates all state  
2 employees, and values the vital work those employees perform for  
3 the people of Hawaii. The legislature recognizes the importance  
4 of investing in the state employees' professional development,  
5 so that they may continue to excel in their various roles.

6           Accordingly, the purpose of this Act is to appropriate  
7 moneys to the department of human resources development for:

- 8           (1) The establishment of positions to expand the  
9           department's ability to offer professional development  
10           programs for state employees; and  
11           (2) The learning management system.

12           SECTION 2. There is appropriated out of the general  
13 revenues of the State of Hawaii the sum of \$           or so  
14 much thereof as may be necessary for fiscal year 2023-2024 and  
15 the same sum or so much thereof as may be necessary for fiscal  
16 year 2024-2025 for the establishment of:



- 1 (1) Two permanent full-time equivalent (2.0 FTE) human
- 2 resource specialist positions;
- 3 (2) Three permanent full-time equivalent (3.0 FTE) general
- 4 professional positions; and
- 5 (3) One permanent full-time equivalent (1.0 FTE) human
- 6 resource technician position;
- 7 to expand the ability of the training branch of the employee
- 8 relations division to offer professional development programs
- 9 for state employees.

10 The sums appropriated shall be expended by the department  
 11 of human resources development for the purposes of this Act.

12 SECTION 3. There is appropriated out of the general  
 13 revenues of the State of Hawaii the sum of \$ or so  
 14 much thereof as may be necessary for fiscal year 2023-2024 and  
 15 the same sum or so much thereof as may be necessary for fiscal  
 16 year 2024-2025 for the expansion of offerings within the  
 17 learning management system.

18 The sums appropriated shall be expended by the department  
 19 of human resources development for the purposes of this Act.

20 SECTION 4. There is appropriated out of the general  
 21 revenues of the State of Hawaii the sum of \$ or so



1 much thereof as may be necessary for fiscal year 2023-2024 and  
2 the same sum or so much thereof as may be necessary for fiscal  
3 year 2024-2025 for the purchase of licenses to enable the  
4 learning management system to become the single system of record  
5 for the State.

6 The sums appropriated shall be expended by the department  
7 of human resources development for the purposes of this Act.

8 SECTION 5. This Act shall take effect on June 30, 3000.
