## A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST ITEMS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

### PART I

2 SECTION 1. In accordance with section 9 of article VII, of the Constitution of the State of Hawaii and sections 37-91 and 3 4 37-93, Hawaii Revised Statutes, the legislature has determined 5 that the appropriations contained in this Act will cause the state general fund expenditure ceiling for fiscal year 2024-2025 6 7 to be exceeded by \$ , or per cent. The 8 reasons for exceeding the general fund expenditure ceiling are 9 that the appropriations made in this Act are necessary to serve 10 the public interest and to meet the needs provided for by this 11 Act.

SECTION 2. There is appropriated from the general revenues of the State of Hawaii to the senate, house of representatives, and legislative agencies indicated below, the following sums or so much thereof as may be necessary for fiscal year 2024-2025, to fund Hawaii employer-union health benefits trust fund costs and other cost adjustments authorized by chapter 89C, Hawaii
