# A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE  
TWENTY-FIFTH REPRESENTATIVE DISTRICT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The director of finance is authorized to issue  
2 general obligation bonds in the sum of \$23,471,000 or so much  
3 thereof as may be necessary and the same sum or so much thereof  
4 as may be necessary is appropriated for fiscal year 2024-2025  
5 for the purpose of capital improvement projects for the twenty-  
6 fifth representative district, as follows:

7 1. Ke'elikōlani middle school

8 Design and construction for paving of  
9 parking lots.

10 Design \$50,000

11 Construction \$500,000

12 Total funding \$550,000

13 The sum appropriated for this capital improvement project  
14 shall be expended by the department of education.

15 2. McKinley high school



1 Design and construction for the  
 2 renovation of science classrooms MS2  
 3 and MS9 in building M.

4	Design	\$1,000
5	Construction	\$2,500,000

6	Total funding	\$2,501,000

7 The sum appropriated for this capital improvement project  
 8 shall be expended by the department of education.

9 3. McKinley high school

10 Design and construction for the  
 11 renovation of science classrooms MS3  
 12 and MS11 in building M.

13	Design	\$500,000
14	Construction	\$2,000,000

15	Total funding	\$2,500,000

16 The sum appropriated for this capital improvement project  
 17 shall be expended by the department of education.

18 4. McKinley high school

19 Design and construction for athletic  
 20 complex improvements, including  
 21 bleachers, locker rooms, stadium,



1 general field lighting, and other  
 2 physical education and athletic  
 3 facilities; ground and site  
 4 improvements; and equipment and  
 5 appurtenances.

6	Design	\$100,000
7	Construction	\$17,820,000
8	Total funding	\$17,920,000

9 The sum appropriated for this capital improvement project  
 10 shall be expended by the department of education.

11 SECTION 2. The appropriation made for the capital  
 12 improvement projects authorized by this Act shall not lapse at  
 13 the end of the fiscal year for which the appropriation is made;  
 14 provided that all moneys from the appropriation unencumbered as  
 15 of June 30, 2026, shall lapse as of that date.

16 SECTION 3. This Act shall take effect on July 1, 2024.
