# A BILL FOR AN ACT

RELATING TO SPECIAL NUMBER PLATES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Keawalau o Puuloa,
- 2 also known as Puuloa or Pearl Harbor, was first settled around
- 3 400 A.D. and is a place of cultural significance that
- 4 exemplifies the power of positive, community-led change. The
- 5 Maweke family, one of the original families who settled in the
- 6 area, is credited with bringing sweet potato from Peru to Ewa
- 7 and dredging an entrance to allow large voyaging canoes to pass
- 8 over the shallow entrance to Puuloa. Puuloa's ancient
- 9 settlements near present-day Honouliuli, also known as West
- 10 Loch, represent the first and oldest settlements on the island
- 11 of Oahu. The area near Puuloa also served as a major political
- 12 capital in Ewa that governed the island of Oahu.
- The legislature also finds that Puuloa was an abundant
- 14 water resource that contained at least thirty loko ia,
- 15 traditional Hawaiian fishponds, and loi kalo, patches of land
- 16 for taro cultivation. A convergence of estuaries, perennial
- 17 freshwater springs, shallow aquifers, and healthy nutrient



- 1 runoff provided loko ia and loi kalo with regenerative resources
- 2 needed to feed surrounding settlements. However, Puuloa's
- 3 aquatic resources have been exposed and contaminated with
- 4 mercury, polychlorinated biphenyls, dioxins, pesticides,
- 5 microplastics, lead, and other harmful chemicals and materials
- 6 from multiple polluted runoff sources. Many toxins present in
- 7 Puuloa persist in the environment for significant periods of
- 8 time and bioaccumulate in the tissues of fish, aquatic plants,
- 9 and wildlife that live in the local ecosystems.
- 10 The legislature further finds that Hui o Ho'ohonua is a
- 11 501(c)(3) nonprofit organization doing business under the trade
- 12 name Mālama Pu'uloa, with a mission to address the historical
- 13 trauma to the land, water, and people in the Ewa Moku on Oahu.
- 14 Created by the members of the Ewa community, this mission was
- 15 motivated by the environmental neglect and pollution in Peal
- 16 Harbor.
- 17 Accordingly, the purpose of this Act is to authorize the
- 18 issuance of special number plates to recognize and honor Malama
- 19 Puuloa.

1	SECTION 2. Chapter 249, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§249- Special number plates for Malama Puuloa;
5	authorized. (a) Notwithstanding any law to the contrary, the
6	director of finance shall issue to any registered owner of a
7	motor vehicle, who is a resident of the State and has completed
8	the application and paid the required fees, a special number
9	plate for the registered owner's motor vehicle that commemorates
10	Malama Puuloa and observes the organization's contributions to
11	the restoration of Puuloa, also known as Pearl Harbor.
12	(b) The director of finance of the city and county of
13	Honolulu, in consultation with the directors of finance of the
14	counties of Kauai, Maui, and Hawaii; the chiefs of police of the
15	city and county of Honolulu and the counties of Kauai, Maui, and
16	Hawaii; and the chief executive officer of Hui o Ho'ohonua shall
17	establish a special number plate design that:
18	(1) Contains words, images, or both, that indicate the
19	special number plate is issued to recognize Malama
20	Puuloa;

1	(2)	Is similar in shape and size to the uniform state
2		number plate prescribed by law; and
3	(3)	Does not obstruct the visibility of the number or
4		letters or any other information that is required by
5		law to be on a number plate and is readily
6		identifiable and distinguishable under actual traffic
7		conditions;
8	provided	that the director of finance of the city and county of
9	Honolulu	may also establish additional special number plate
10	designs i	n conformance with this subsection and subsection (c)
11	that join	tly or separately recognize Malama Puuloa.
12	(c)	The special number plate design shall not:
13	(1)	Infringe upon or otherwise violate any trademark,
14		trade name, service mark, copyright, or other
15		proprietary or property right;
16	(2)	Represent any obscene or degrading image, idea, word,
17		or phrase;
18	(3)	Advertise or endorse a product, brand, or service that
19		is provided for sale;
20	(4)	Promote any religious belief; or

1	(3) Promote any philosophy based on prejudice or that is
2	contrary to state civil rights laws.
3	(d) Each special number plate shall be securely fastened
4	to the motor vehicle in lieu of the uniform state number plate.
5	(e) The director of finance shall charge a special number
6	plate fee at least equal to the county's cost of providing the
7	special number plate and administrative costs, if any, plus a
8	fundraising fee to be determined by the director of finance in
9	consultation with the chief executive officer of Hui o Ho'ohonua.
10	The fundraising fee shall be in addition to any other state or
11	county fees collected for a motor vehicle registration or
12	license plate.
13	(f) The director of finance may charge an additional
14	fundraising fee, of the same or a different amount as the
15	fundraising fee established pursuant to subsection (e), for the
16	renewal of a special number plate. If an additional fundraising
17	fee is implemented pursuant to this subsection, the director of
18	finance shall not renew and instead shall revoke the special
19	number plate of the registered owner of a motor vehicle who
20	fails to pay the additional fundraising fee imposed by this
21	subsection.

1	(g) The revenue generated by the fundraising fees, or a
2	portion of the revenue generated by the fundraising fees as
3	determined by the director of finance, shall be deposited in the
4	name of Malama Puuloa in a separate county budget account. The
5	director of finance shall determine the most efficient means of
6	directing the net revenue generated by the fundraising fees to
7	Malama Puuloa, as appropriate, to fund the restoration of
8	Puuloa, or Pearl Harbor.
9	(h) The director of finance may revoke all special number
10	plates issued pursuant to this section if the total number of
11	registered owners of motor vehicles who obtain the special
12	number plates is less than one hundred fifty within three years
13	of issuance of the first special number plate.
14	(i) Nothing in this section shall be construed to apply to
15	any plates issued pursuant to section 249-9.2.
16	(j) For the purposes of this section, unless a different
17	meaning appears from the context, "special number plate" means a
18	license plate that commemorates Malama Puuloa."

SECTION 3. New statutory material is underscored.
