A BILL FOR AN ACT

RELATING TO POST-SECONDARY EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that community colleges 2 play a vital role in meeting the State's employment needs. The 3 legislature further finds that, as a means to develop a well-4 trained and high qualified workforce, this Act addresses an 5 issue of statewide concern. A well-trained and highly qualified workforce will attract employers to the State, diversify the 6 7 local economy, and allow Hawaii to compete in the global market. 8 The purpose of this Act is to continue the State's efforts 9 to provide free public education for students in kindergarten 10 through community college by establishing a pilot program for 11 community college tuition waivers.

SECTION 2. (a) There is established a community collegetuition waiver pilot program.

(b) Beginning with the 2025 fall semester, the board of regents of the university of Hawaii shall waive the tuition of any person who is admitted to and enrolled full-time at a community college campus of the university of Hawaii that is
