HOUSE OF REPRESENTATIVES THIRTY-SECOND LEGISLATURE, 2024 STATE OF HAWAII H.B. NO. 2747

A BILL FOR AN ACT

RELATING TO CREATIVE MEDIA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the Hawaii film and 2 television industry has continued to grow over the past twenty 3 years due, in part, to various state incentives that allow the 4 State to effectively subsidize some production costs. These 5 public-private partnerships have not only increased the number 6 of feature films, television series, and commercial productions 7 filming in Hawaii, but have also directly increased the number 8 of media-related jobs and the amount of tax revenue to the 9 State. During 2020, film production in Hawaii generated a net 10 of \$104,900,000 in gross domestic product, and many times that 11 figure in economic benefits from that spending.

12 The legislature further finds that film festivals working 13 with capitol modern, formerly known as the Hawaii state art 14 museum, and other institutions have helped to support Hawaii 15 filmmakers by promoting new and emerging talent in Hawaii, 16 helping to provide careers in creative media, increasing funding 17 sources for filmmaking, and supporting creative media

1	collaborations through educational programs. Film festivals in
2	Hawaii attract tens of thousands of viewers and generate
3	millions of dollars of further spending and economic benefits.
4	Accordingly, the purpose of this Act is to establish a
5	filmmakers special fund for the state foundation on culture and
6	the arts to award grants for film, media, and creative
7	industries intellectual property development projects that are
8	created and produced in Hawaii by Hawaii resident filmmakers.
9	SECTION 2. (a) There is established within the department
10	of accounting and general services the filmmakers special fund
11	into which shall be deposited:
12	(1) Appropriations by the legislature to the special fund;
13	and
14	(2) Gifts, donations, and grants from public agencies and
15	private persons.
16	(b) In consultation with the creative industries division
17	of the department of business, economic development, and
18	tourism, the state foundation on culture and the arts shall
19	award grants from the filmmakers special fund for film, media,
20	and creative industries intellectual property development

projects that are created and produced by Hawaii resident
filmmakers in Hawaii.

3 SECTION 3. In accordance with section 9 of article VII, of the Constitution of the State of Hawaii and sections 37-91 and 4 5 37-93, Hawaii Revised Statutes, the legislature has determined 6 that the appropriations contained in this Act will cause the state general fund expenditure ceiling for fiscal year 2024-2025 7 8 to be exceeded by \$, or per cent. The reasons 9 for exceeding the general fund expenditure ceiling are that the 10 appropriations made in this Act are necessary to serve the 11 public interest and to meet the needs provided for by this Act. 12 SECTION 4. There is appropriated out of the general 13 revenues of the State of Hawaii the sum of \$1,000,000 or so much 14 thereof as may be necessary for fiscal year 2024-2025 for 15 deposit into the filmmakers special fund.

16 SECTION 5. There is appropriated out of the filmmakers 17 special fund the sum of \$1,000,000 or so much thereof as may be 18 necessary for fiscal year 2024-2025 for the state foundation on 19 culture and the arts to award grants for film, media, and 20 creative industries intellectual property development projects 21 in Hawaii.

The sum appropriated shall be expended by the state
foundation on culture and the arts for the purposes of this Act.
SECTION 6. This Act shall take effect on July 1, 2024;
provided that this Act shall be repealed on June 30, 2029.
