A BILL FOR AN ACT

RELATING TO MAGNET SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that there is a need to create more education opportunities for children in the public school system. The legislature further finds that it is critical for students to learn skills and tools necessary to support the unique needs of their communities in Hawaii. Magnet schools address these needs by offering specialized curriculums with a common theme or focus.

8 The legislature notes that Waiāhole elementary school has 9 incorporated a specialized agricultural curriculum in Waiāhole 10 and Ka'a'awa elementary school has incorporated a specialized 11 "mauka to makai" watershed curriculum in Ka'a'awa. Both schools 12 have gathered community partners and resources to allow students 13 access to invaluable learning opportunities in their 14 communities. These learning opportunities are critical to help 15 the State meet its goals for food sustainability and combating 16 climate change.

1 The legislature notes that currently, Hawaii imports 2 between ninety and ninety-five per cent of its food. The 3 agricultural curriculum at Waiāhole elementary school will teach 4 the State's children and their families how to be food self-5 sufficient and will encourage the growth of agricultural 6 initiatives, such as farm-to-table and farm-to-school, as a 7 driving economic sector in Hawaii. Additionally, the "mauka to 8 makai" watershed curriculum at Ka'a'awa elementary school will 9 contribute to achieving the State's climate goals through the 10 hands-on experience students receive at the coast, located 11 across from the school. The coastal erosion and flooding caused 12 by climate change affect the State's very foundation, and 13 through the "mauka to makai" curriculum students at Ka'a'awa 14 elementary school will be able to learn about the issues that 15 directly impact them. Providing education on climate change 16 issues such as coastal erosion is essential to creating a future 17 workforce that will tackle these important and ongoing concerns. 18 The purpose of this Act is to establish a five-year magnet 19 school pilot program, using Waiāhole elementary school and 20 Ka'a'awa elementary school as pilot magnet schools.

3 (e) The department of education shall submit a report of 4 its findings and recommendations, including any proposed legislation, regarding the magnet school pilot program to the 5 6 legislature no later than twenty days prior to the convening of 7 the regular session of 2029. The report shall include the 8 effects of the pilot program on enrollment at Waiāhole and 9 Ka'a'awa elementary schools, changes in usage of community 10 resources, and a recommendation of whether the pilot program 11 should be continued, modified, or terminated.

12 (f) The magnet school pilot program shall cease to exist13 at the end of the 2028-2029 school year.

14 (q) For the purposes of this Act, "magnet school" means a 15 public elementary school or public secondary school that offers 16 a specialized curriculum with a common theme or focus, in which 17 enrollment may be chosen as an alternative to enrollment in a 18 school pursuant to section 302A-1143, Hawaii Revised Statutes, 19 and that is capable of attracting substantial numbers of 20 students with diverse demographic backgrounds from a broad 21 geographical area.

1	SECTION 3. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$ or so
3	much thereof as may be necessary for fiscal year 2023-2024 and
4	the same sum or so much thereof as may be necessary for fiscal
5	year 2024-2025 for the establishment of the magnet school pilot
6	program and eight full-time equivalent (8.0 FTE) positions as
7	follows:
8	(1) Two full-time equivalent (2.0 FTE) counselors;
