

### A BILL FOR AN ACT

RELATING TO STATE FUNDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. The legislature finds that the federal funding
- 5 received under the American Rescue Plan (ARP) Act of 2021,
- 6 Public Law 117-2, required that states receiving elementary and
- 7 secondary school emergency relief (ESSER) program III funds for
- 8 maintenance of effort for fiscal year 2022-2023 maintain State
- 9 support for elementary and secondary education that is at least
- 10 at the proportional level of the State's support for elementary
- 11 and secondary education relative to the State's overall
- 12 spending, averaged over fiscal years 2016-2017, 2017-2018, and
- 13 2018-2019. If the State fails to meet these requirements, the
- 14 United States Department of Education has the authority to
- 15 impose a range of enforcement options, including seeking
- 16 recovery of the approximately \$412,300,000 in ESSER program III
- 17 funds awarded to the state department of education.



## H.B. NO. 679

1 As the State's economy has improved and general fund 2 revenues have rebounded, the State's maintenance of effort 3 obligation has become increasingly difficult to manage, in part 4 due to certain large general fund appropriations made in fiscal 5 year 2021-2022 and fiscal year 2022-2023 for non-educational purposes. These appropriations were made for worthy purposes 7 but have the impact of increasing the denominator for ARP ESSER 8 maintenance of effort calculations if expended in fiscal year 9 2022-2023. However, these worthy purposes would not be 10 adversely affected by statutory adjustments to modestly delay 11 expenditures beyond fiscal year 2022-2023, to ensure the 12 expenditures no longer impact the ARP ESSER maintenance of 13 effort calculations. 14 The purpose of this Act is to reduce the potential for 15 federal ARP ESSER maintenance of effort enforcement actions 16 against the State by delaying the encumbrance and expenditure of 17 various large general fund appropriations made by the 18 legislature in the regular session of 2022 until or beyond 19 July 1, 2024, so these expenditures are no longer part of the 20 fiscal year 2022-2023 ARP ESSER maintenance of effort 21 calculations.

# H.B. NO. 679

1	SECTION 3. Act 236, Session Laws of Hawaii 2022, is
2	amended by amending section 3 to read as follows:
3	"SECTION 3. There is appropriated out of the general
4	revenues of the State of Hawaii the sum of \$300,000,000 or so
5	much thereof as may be necessary for fiscal year 2022-2023 to be
6	deposited into the rental housing revolving fund established in
7	section 201H-202, Hawaii Revised Statutes[+]; provided that
8	funds shall not be expended or deposited into the rental housing
9	revolving fund prior to July 1, 2023; provided further that any
10	unencumbered balances from the appropriation shall lapse to the
11	general fund on June 30, 2024."
12	SECTION 4. Statutory material to be repealed is bracketed
13	and stricken. New statutory material is underscored.
14	SECTION 5. This Act shall take effect upon its approval.
