
A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$ or so
3 much thereof as may be necessary for fiscal year 2023-2024 and
4 the same sum or so much thereof as may be necessary for fiscal
5 year 2024-2025 for the Hawaii climate-smart commodities program
6 of the college of tropical agriculture and human resources of
7 the University of Hawaii at Manoa.

8 The sums appropriated shall be expended by the University
9 of Hawaii for the purposes of this Act.

10 SECTION 2. There is appropriated out of the general
11 revenues of the State of Hawaii the sum of \$ or so
12 much thereof as may be necessary for fiscal year 2023-2024 to
13 continue the science, technology, engineering, and mathematics
14 training for students through the Hawaii space flight
15 laboratory.

16 The sum appropriated shall be expended by the University of
17 Hawaii for the purposes of this Act.



1 SECTION 3. There is appropriated out of the general
 2 revenues of the State of Hawaii the sum of \$ or so
 3 much thereof as may be necessary for fiscal year 2023-2024 and
 4 the same sum or so much thereof as may be necessary for fiscal
 5 year 2024-2025 for the center for pacific innovations,
 6 knowledge, and opportunities.

7 The sums appropriated shall be expended by the University
 8 of Hawaii for the purposes of this Act.

9 SECTION 4. There is appropriated out of the general
 10 revenues of the State of Hawaii the sum of \$ or so
 11 much thereof as may be necessary for fiscal year 2023-2024 and
 12 the same sum or so much thereof as may be necessary for fiscal
 13 year 2024-2025 for the change Hawaii project and Hawaii mesonet
 14 project to stimulate competitive research.

15 The sums appropriated shall be expended by the University
 16 of Hawaii for the purposes of this Act.

17 SECTION 5. There is appropriated out of the general
 18 revenues of the State of Hawaii the sum of \$ or so
 19 much thereof as may be necessary for fiscal year 2023-2024 and
 20 the same sum or so much thereof as may be necessary for fiscal



1 year 2024-2025 for a prototype designer artificial coral reef
2 project.

3 The sums appropriated shall be expended by the University
4 of Hawaii for the purposes of this Act.

5 SECTION 6. This Act shall take effect on June 30, 3000.
