### A BILL FOR AN ACT

RELATING TO THE SALE OF ANIMALS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 142, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" <u>§142-</u> Sale of dogs, cats, and rabbits; prohibited.
5	(a) No pet dealer or retail pet store in the State shall sell,
6	offer to sell, lease, offer to lease, barter, auction, or
7	otherwise transfer ownership of any dog, cat, or rabbit.
8	(b) This section shall not be construed to prohibit a pet
9	dealer or retail pet store from collaborating with the following
10	entities to provide space to showcase dogs, cats, or rabbits
11	owned by these entities for the purpose of adoption:
12	(1) Any duly incorporated society for the prevention of
13	cruelty to animals;
14	(2) Any duly incorporated humane society;
15	(3) Any duly incorporated animal protective association;

1	(4) Any other duly incorporated animal adoption or animal
2	rescue organization,
3	that is exempt from taxation under section 501(c)(3) of the
4	Internal Revenue Code; provided that the entities identified in
5	paragraphs (1) to (4) are not affiliated with or located on the
6	premises of a breeder or pet dealer; do not obtain dogs, cats,
7	or rabbits from a breeder or pet dealer in exchange for payment
8	or any form of compensation; and do not resell dogs, cats, or
9	rabbits obtained from a breeder or pet dealer or provide payment
10	or compensation to such breeder or pet dealer.
11	(c) As used in this section:
12	"Animal" includes a dog, cat, or rabbit.
13	"Breeder" means any person who breeds and sells or offers
14	for sale twenty-five or more animals per year for profit.
15	"Pet dealer" means any person who, in the ordinary course
16	of business, sells or offers for sale more than nine animals per
17	year for profit to the public. "Pet dealer" includes a breeder
18	but does not include a retail pet store.
19	"Retail pet store" means any for-profit place of business
20	that sells or offers for sale animals to be kept as household
21	pets, pet food, or pet supplies. "Retail pet store" does not

1	include breeders who sell or offer to sell directly to the
2	public animals that are born and raised on the breeder's
3	residential premises.
4	"Residential premises" includes a person's entire
5	residential property, including a dwelling, garage, yard,
6	garden, and kennel."
7	SECTION 2. New statutory material is underscored.
8	SECTION 3. This Act shall take effect on January 1, 2024.
