A BILL FOR AN ACT

RELATING TO ILLEGAL FIREWORKS TASKFORCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) There shall be established within 2 the department of the attorney general for administrative 3 purposes the 2023 illegal fireworks task force. The task 4 force shall use the findings from the legislative reference bureau's 2019 report, "Blast from the Past: 5 An Update to the Report of the Illegal Fireworks Task Force 6 to the Legislature for the Regular Session of 2011", as 7 8 the basis for developing a comprehensive strategic plan to stop the importation of illegal fireworks and 9 10 explosives into Hawaii; promote compliance with the state fireworks control law; and ensure the safety and security 11 of the airports, harbors, and other facilities and 12 13 institutions in the State against the discharge of 14 illegal fireworks and explosives.

15 (b) The attorney general or attorney general's16 designee shall be the chair of the task force.

17 (c) The following individuals or their designees18 shall serve as members of the task force:
