A BILL FOR AN ACT

RELATING TO EXEMPTIONS FROM JURY DUTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that due to the critical roles that physicians, members of the armed forces, police, 2 firefighters, and emergency medical service members play in 3 ensuring the safety of the public welfare in emergency 4 5 situations, these individuals are currently exempt from jury duty pursuant to section 612-6, Hawaii Revised Statutes. The 6 legislature also finds that, pursuant to chapter 127A, Hawaii 7 Revised Statutes, the Hawaii emergency management agency and 8 9 county emergency management agencies also serve essential, critical, and unique roles and functions to provide emergency 10 management for the State. The legislature therefore finds it 11 12 important that active members of these agencies face no hindrances in serving in their roles; however, existing law does 13 14 not exempt them from jury duty.

Accordingly, the purpose of this Act is to facilitate the implementation of the policy and purpose of chapter 127A, Hawaii Revised Statutes, by exempting active members of the Hawaii

(a) A person may claim exemption 5 from service as a juror if the person is: 6 7 (1) An elected official while the legislature is in 8 session, or a judge of the United States, State, or 9 county; An actively practicing physician or dentist; 10 (2)A member of the armed forces or militia when on active 11 (3) service and deployed out-of-state; 12 An active member of a police or fire department; 13 (4)A person who has served as a juror, either in a court 14 (5) of this State or the United States District Court for 15 the District of Hawaii, within one year preceding the 16 time of filling out the juror qualification form; 17 18 (6) An active member of an emergency medical services 19 agency; A person living more than seventy miles from the court 20 (7) 21 for which jury service is required;
