8	1, is amended by amending the definition of "agricultural
9	enterprise lands" in Section -2, Hawaii Revised Statutes, to
10	read as follows:
11	""Agricultural enterprise lands" means agricultural lands
12	that are [not designated as agricultural parks or non-
13	agricultural park lands] transferred to and managed by the
14	<u>department</u> pursuant to <u>this</u> chapter [ <del>166 or 166E</del> ]."

#### DEPARTMENT: AGRICULTURE

TITLE: A BILL FOR AN ACT RELATING TO AGRICULTURAL LANDS.

PURPOSE: To amend the definitions of "agricultural enterprise lands" and "non-agricultural park lands" for consistency.

- MEANS: Amend Act 221, Session Laws of Hawaii 2022, section 1 (section -2, Hawaii Revised Statutes (HRS)) and section 166E-2, HRS.
- JUSTIFICATION: Act 221, Session Laws of Hawaii 2022 (Act 221), created the Agricultural Enterprise Program within the Hawaii Department of Agriculture (HDOA). Act 221 gives the HDOA the ability to lease lands managed by the HDOA for related agricultural activity, rather than solely for crop development and production. However, the definition of "agricultural enterprise lands" in Act 221 inadvertently created an inconsistency with the definition of "non-agricultural park lands" in chapter 166E, HRS. This bill remedies the inconsistency.

Impact on the department and other agencies: Provide consistency between the Agricultural Enterprise Program and Non-Agricultural Park Program.
