
HOUSE CONCURRENT RESOLUTION

RESOLVING TO END HOMELESSNESS ON MAUI.

1 WHEREAS, Hawai'i has one of the most severe homelessness
2 epidemics In the U.S.A.; and

3
4 WHEREAS, the 2023 point in time count determined there were
5 6223 homeless in the state of Hawaii and 704 on Maui before the
6 August 8, 2023 wildfires; and

7
8 WHEREAS, per the U.S. Department of Housing and Urban
9 Development's 2023 Annual Homeless Assessment Report, Hawai'i
10 had the highest percentage of people experiencing chronic
11 homelessness; and

12
13 WHEREAS, Hawai'i also had the third highest rate of homeless
14 youth staying in unsheltered locations; and

15
16 WHEREAS, recent Maui Fires have increased homelessness; and

17
18 WHEREAS, homelessness can have many causes including family
19 violence, limited housing opportunities, lack of adequate
20 employment, substance addiction, mental/physical health
21 conditions, trauma, lack of adequate employment and other
22 factors; and

23
24 WHEREAS, Hawai'i's housing costs are extremely high and
25 average incomes fails to meet criteria for many rentals; and

26
27 WHEREAS, the price of housing in Hawai'i is a large factor
28 in why the homeless population is growing; and

29
30 WHEREAS, it is extremely difficult to find affordable
31 housing in Hawai'i; and

2 WHEREAS, native Hawaiians are particularly susceptible to
3 homelessness; and

4
5 WHEREAS, housing people reduces suffering; and

6
7 WHEREAS, housing people reduces medical costs; and

8
9 WHEREAS, living on the streets frequently leads to an early
10 death; now, therefore,

11
12 BE IT RESOLVED by the House of Representatives of the Thirty-
13 second Legislature of the State of Hawai'i, Regular Session of
14 2024, the Senate concurring, that significantly increased
15 efforts must be made to house people in Hawai'i; and

16
17 BE IT FURTHER RESOLVED that we request of the Governor and
18 his Coordinator on Homelessness and Housing Solutions to secure
19 a viable location on Maui and build at least 450 homes for the
20 displaced victims of the Lahaina wildfires; and

21
22 BE IT FURTHER RESOLVED that we request of the Governor and his
23 Coordinator on Homelessness and Housing Solutions to secure at
24 least two different geographic locations on Maui to build a
25 Kauhale for any displaced Lahaina wildfire victims as well as
26 homeless prior to the August 8, 2023 wildfires and ensure
27 outreach services to provide for mental health, crisis
28 stabilization, along with any wraparound social services for all
29 residents of the new housing units; and

31 BE IT FURTHER RESOLVED that Maui needs to house an
32 estimated 800 homeless and the State will move forward with
33 compassion and aloha to help these people by constructing new
34 housing units on Maui; and

35
36 BE IT FURTHER RESOLVED that the State and the people of
37 Hawai'i want to house the houseless, shelter those with no
38 shelter, and find homes for all of the housing insecure; and

40 BE IT FURTHER RESOLVED that certified copies of this
41 Concurrent Resolution be transmitted to The Honorable Governor
42 Joshua Green, the Honorable State Coordinator on Homelessness
43 and Housing Solutions John Mizuno, The Speaker of the House of
