## HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND TOURISM TO CONVENE A SPORTS WAGERING WORKING GROUP TO CONDUCT AN ANALYSIS OF THE POTENTIAL LEGALIZATION AND REGULATION OF ONLINE SPORTS WAGERING IN HAWAII.

WHEREAS, a robust illegal sports betting market thrives in 1 the absence of a legal, regulated framework; and 2 3 4 WHEREAS, the American Gaming Association estimates that Americans wager over \$63,000,000,000 each year in the illegal 5 market with no oversight, consumer protections, or tax revenue 6 7 generated; and 8 9 WHEREAS, sports wagering is offered safely and responsibly by reputable operators in jurisdictions where sports wagering is 10 legal, and these operators implement robust measures with regard 11 to identity verification, consumer protection, responsible 12 13 gaming, and game integrity that are not present in the illegal market; and 14 15 WHEREAS, by channeling this activity into a legal market 16 17 and building a robust, responsible, and regulated market for sports wagering, Hawaii stands to gain millions of dollars each 18 year in additional tax revenue; and 19 20 WHEREAS, the legalization of sports wagering presents an 21 opportunity to generate significant revenue for Hawaii; now, 22 23 therefore, 24 BE IT RESOLVED by the House of Representatives of the 25 Thirty-second Legislature of the State of Hawaii, Regular 26 Session of 2024, the Senate concurring, that the Department of 27 28 Business, Economic Development, and Tourism is requested to convene a Sports Wagering Working Group to conduct an analysis 29
