HOUSE CONCURRENT RESOLUTION

REQUESTING THE INSURANCE COMMISSIONER TO COORDINATE AND DEVELOP A WILDFIRE INSURANCE COMPACT.

WHEREAS, the State is facing the increasing challenge of 1 wildfires, which has been exacerbated by climate change that is 2 responsible for more intense and more frequent extreme events 3 such as wildfires, storms, droughts, and floods; and 4 5 WHEREAS, wildfires pose significant risks to the health, 6 7 safety, and welfare of the State's residents, visitors, and businesses; and 8 9 WHEREAS, on August 8, 2023, swift moving wildfires fueled 10 by dry grass and spread by strong winds from a passing hurricane 11 wiped out almost the entire town of Lahaina in west Maui, in the 12 13 nation's deadliest wildfire in more than a century; and 14 WHEREAS, at least one hundred fifteen people lost their 15 life in the fire, over two thousand two hundred buildings were 16 destroyed and another five hundred damaged, resulting in 17 18 property losses in the billions; and 19 WHEREAS, the impacts from the Lahaina wildfires were 20 21 devasting to the west Maui community and, with impacts felt throughout the entire State; and 22 23 24 WHEREAS, the recovery is expected to be long and arduous; 25 and 26 WHEREAS, the aftermath of the deadly Lahaina wildfires 27 poses a significant strain on local insurance companies and 28 communities; and 29 30

WHEREAS, there are concerns that the wildfires could 1 2 trigger insurance companies to reevaluate the risks associated with offering coverage to homeowners in Hawaii, which has long 3 been considered a relatively stable market compared to other 4 5 states; and 6 WHEREAS, the increased risk of wildfires and the resulting 7 8 challenges for insurance companies means the State should explore a coordinated approach to mitigate and manage these 9 10 risks; now, therefore, 11 12 BE IT RESOLVED by the House of Representatives of the 13 Thirty-second Legislature of the State of Hawaii, Regular Session of 2024, the Senate concurring, that the Insurance 14 Commissioner is requested to coordinate and develop a Wildfire 15 Insurance Compact with strategic partner states that have 16 similar wildfire risks or robust disaster management systems; 17 18 and 19 20 BE IT FURTHER RESOLVED that the Insurance Commissioner is requested to develop a Wildfire Insurance Compact that focuses 21 primarily on risk pooling and informational technology sharing 22 23 to mitigate and share the risks and costs associated with wildfires; and 24 25 26 BE IT FURTHER RESOLVED that the Insurance Commissioner is requested to propose any necessary legislation that can assist 27 in the funding of policies and programs available through the 28 Wildfire Insurance Compact through taxes or surcharges on 29 30 existing taxes; and 31 BE IT FURTHER RESOLVED that the Insurance Commissioner is 32 requested to ensure that the policies and programs offered by 33 the Wildfire Insurance Compact directly benefit vulnerable 34 populations and communities; and 35 36 BE IT FURTHER RESOLVED that a certified copy of this 37 Concurrent Resolution be transmitted to the Insurance 38 39 Commissioner. 40 41
