HOUSE RESOLUTION

REQUESTING THE BOARD OF AGRICULTURE TO CONDUCT A STUDY ON THE PERCENTAGES OF AGRICULTURAL LANDS BEING LEASED BY THE STATE THAT ARE SUITABLE FOR FARMING AND ACTIVELY BEING USED FOR FARMING PURPOSES AND CERTAIN DOLLAR AMOUNTS RELATING TO LEASE TRANSFERS.

WHEREAS, state agricultural lands are a key resource that 1 can be used to meet the State's goals for economic 2 diversification and food self-sufficiency; and 3 4 WHEREAS, to support farmers on these lands, the State 5 subsidizes lessees by providing the leases below market rates 6 and, in some cases, providing lower-cost agricultural water; and 7 8 WHEREAS, despite state subsidies, some state agricultural 9 leases are used primarily as residences or non-agricultural 10 businesses or are unused; and 11 12 WHEREAS, lessees who obtain a state agricultural lease in 13 high-demand locations can transfer the remainder of their lease 14 to the highest bidder, thereby converting their lease into a 15 windfall profit above and beyond their investment in the 16 17 property; and 18 WHEREAS, this windfall profit to the lessee is an 19 unintended transfer of wealth from the State to individual 20 lessees; and 21 22 WHEREAS, this situation also causes the transfers of leases 23 to the highest bidder, who may or may not be the farmers best 24 able to use the land for agricultural production; and 25 26 27 WHEREAS, further data is needed to assess to what extent Department of Agriculture leases maximize the benefit to the 28 State of these lands to help the State achieve its economic and 29 food production goals; and 30
