HOUSE RESOLUTION

DESIGNATING THE KO'OLAU KUPUNA COUNCIL AS AN ADVISORY RESOURCE TO THE ELECTED MEMBERS OF THE HAWAII STATE LEGISLATURE REPRESENTING THE KO'OLAU COMMUNITY.

WHEREAS, from time immemorial, kupuna have held respected 1 2 and revered positions within Hawaii's households, families, and 3 communities; and 4 WHEREAS, today, kupuna play an essential role in advising 5 on appropriate actions that enable smooth and efficient 6 relationships among members of households, families, businesses, 7 8 and the community; and 9 WHEREAS, the Koʻolau community recently formed the Koʻolau 10 Kupuna Council, comprised of kupuna who are sixty years of age 11 or older and are long-time residents of Eastside Oahu and 12 Hawaiian cultural practitioners who possess historical and 13 cultural knowledge about the Koolau region and community; and 14 15 16 WHEREAS, it is of great significance to the Koʻolau community for the Koʻolau Kupuna Council to meet with elected 17 officials representing the Ko'olau community on a regular basis 18 19 to provide, in the spirit of aloha and with humility, input on 20 various issues that are of importance to the Ko'olau community; 21 and 22 23 WHEREAS, formal recognition of the Koʻolau Kupuna Council as an advisory resource to elected members of the Hawaii State 24 25 Legislature who represent the Koʻolau community is imperative to enable the Council to share its wisdom and advice on matters of 26 27 importance to the Ko'olau community; now, therefore, 28 29 BE IT RESOLVED by the House of Representatives of the 30 Thirty-second Legislature of the State of Hawaii, Regular Session of 2024, that the Ko'olau Kupuna Council is designated by 31

the Hawaii State Legislature as an advisory resource to its 1 elected members representing the Ko'olau community; and 2 3 BE IT FURTHER RESOLVED that elected members of the Hawaii 4 State Legislature representing the Ko'olau community are 5 requested to meet with the Ko'olau Kupuna Council and any of its 6 7 subsequent chapters on a regular basis to receive input on various issues that are of importance to the Ko'olau community; 8 and 9 10 BE IT FURTHER RESOLVED that certified copies of this 11 Resolution be transmitted to Chairperson of the Ko'olau Kupuna 12 Council. 13 14 15 16
